
Lancashire County Council Children & Young People's Public Health Commissioning—Child Health Profiles 2017

Public Health, assisted by Business Intelligence within Lancashire County Council have created 34 middle level (MSOA* cluster) Child Health Profiles (CHPs). This is because the CHPs on the Public Health England website are only at upper tier level. This does not show the outcome data at sub-district level but just an overview of children and young people's health across the whole of County. These lower level profiles highlight where children's health needs are the greatest and opportunities to reduce inequalities are greatest.



LEYLAND

There are 11 primary and 4 secondary schools in Leyland. There are 2 independent schools and 1 further education facility.

There are 5 GP practices.

Emergency admissions in 0-4 year olds in Leyland are high (ranked 5 of the 34 CHPs where 34 = best.

A high (6%) proportion of young people are not in education, employment or training (5th). 3.4 children per 1000 living in Leyland were killed or seriously injured in road traffic accidents (5th).


25% of reception children (7th) and 32% of year 6 children (11th) are classed as overweight.

48% of 10/11 year olds attain education key stage 2 (8th) but a higher rate attain key stage 4 (58% - 17th).

17% of children live in poverty in Leyland (16th) and 15% claim free school meals (10th). 3.4% of maternities are to mums aged <20 years (17th).

The 'best' indicator for Leyland is the A&E attendance rate for 0-4 year olds with 432 per 1000 0-4 year olds (20th).

The top seven being **red** (worst 5th), the next seven being **orange** (2nd worst 5th) the mid 6 being **yellow** (middle 5th) the next to best seven being **blue** (2nd best fifth) and the lowest seven being **green** (best 5th)
