Schools Budget for 2020/21

Following the General Election on 12 December 2019, the Department for Education (DfE) confirmed announcements about additional schools funding that have been mention in previous newsletter articles, and issued Dedicated Schools Grant (DSG) allocations for 2020/21 for every Local Authority, in four funding blocks, each calculated using national funding formulae.

Information on Lancashire's 2020/21 DSG allocations are provided below:

At the Schools Forum meeting on 14 January 2020, school and early years representatives considered proposals for setting the 2020/21 Schools Budget. A meeting of the Lancashire County Council Cabinet was also held on 16 January 2020, where final decisions about the setting of the 2020/21 schools budget were taken. The key headlines from the 2020/21 budget setting process include:

Schools Block

Lancashire continues to use the National Funding Formula (NFF) methodology as the local Lancashire funding model in 2020/21;

For 2020/21, the NFF provides an uplift of 4% on most formula factors and the updated Minimum Pupil Funding (MPF) rates previously announced by the Government:

- Primary £3,750 per pupil
- Secondary £5,000 per pupil

Following a consultation with schools and academies in Lancashire, areas where local discretion is available in 2020/21 were agreed by the Schools Forum and the LCC Cabinet as follows:

- The Minimum Funding Guarantee (MFG) was set at a 2020/21 MFG of +1.84% with no cap on gains (This matches the NFF methodology);
- To transfer Schools Block headroom of circa £2m (0.26% of the Schools Block) once the NFF methodology has been implemented in full as the local formula, to support other funding blocks. (This headroom is generated from Lancashire's Growth allocation).
- To amend the notional SEN to remove the Basic Pupil elements from the calculation.

High Needs Block (HNB)

The extra funding made available nationally for school budgets from April 2020 have provided a considerable increase in HNB funding in Lancashire for 2020/21.

This additional funding will be used to:

- cover the forecast growth in High Needs expenditure from April 2020;
- support increases in HNB expenditure to broadly match uplifts in the mainstream sector, including:
 - o increasing the Weighted Pupil Numbers (WPN) rate by 5% to £4,305;
 - o realigning the 'School Specific' allocation in special schools to be more equitable and transparent
 - Uplift the PRU School Specific rate by 4%;
 - o Uplift the PRU Excluded Pupils, Medical and Other pupils rates in line with NFF rates;
 - o Increase the Hospital Education budget to £858k to cover demand led pressures.

Early Years Block (EYB)

The Government have increased the 2020/21 EYB allocation, but not at the same level of increase that is included in the Schools and High Needs blocks, and there remain considerable cost pressures facing all providers across the sector.

Lancashire will passport additional Government 2020/21 allocations for 2, 3 and 4 years olds by increasing base rates by 8p per hour.

In addition, the Schools Forum has agreed to transfer the £2m headroom from the Schools Block, which will include, for one year only:

- an local increase to the 3&4 year old base rates of an extra 8p per hour, in addition to that provided by the increased Government funding;
- an increased of £200k to the SEN Inclusion Fund from April 2020, to provide a higher budget to support early years pupils with high needs.

2020/21 base rates are shown in the table below:

Other factors within the Early Years Funding Formula will continue, at 2019/20 rates, including the supplementary funding for Maintained Nursery Schools.

Central School Services Block

This Block is to fund central functions that local authorities carry out on behalf of pupils in state-funded maintained schools and academies in England. The Central School Services Block is split into funding for historic commitments and funding for ongoing responsibilities.

The ongoing responsibilities allocation has been reduced in 2020/21, as the DfE seek to eliminate this part of the formula over a period of time.

Issuing Individual Schools Budgets (ISBs)

Proposals for the Schools Block have now been submitted to the Education and Skills Funding Agency (ESFA) for compliance checking against the relevant Regulations before they can be distributed. The authority cannot issue school budgets until we have been notified that the checks are complete and our proposals are compliant. However, it is anticipated that individual budgets should be issued after February 2020 half term, and before the 28 February 2020.

Consultations

97 responses were received from schools in connection with the consultation on key local issues in the funding formula for 2020/21, which asked about:

- The level of the Minimum Funding Guarantee (MFG) and capping in the local formula;
- A possible transfer of headroom only, from the Schools Block to be used in the High Needs Block and the Early Years Block;
- A possible alteration to the Notional SEN calculation.

The majority of responses supported the proposals in the consultation and further details are provided at Appendix A to the newsletter.

The Schools Forum is very grateful for all the comments and responses that have been received. They are vital in shaping the sometimes difficult decisions and recommendations that need to be made.



Other Key Issues

School Teaching & Support Staff Supply Reimbursement Scheme

The School Teaching and Support Staff Supply Reimbursement Scheme arrangements for 2020/21 were agreed by the Forum on 14 January 2020. The Forum agreed that the premiums and reimbursement rates should be increased to take account of the relevant teachers and support staff pay increases.
