This GENERAL VESTING DECLARATION is executed on the 29th day of October 2020
By The Lancashire County Council ("the Authority")

WHEREAS:

- (1) On 11th April 2019 an order entitled THE LANCASHIRE COUNTY COUNCIL (PRESTON WESTERN DISTRIBUTOR, EAST WEST LINK AND COTTAM LINK ROADS) COMPULSORY PURCHASE ORDER 2018 was confirmed with modifications by the Secretary of State for Transport under the powers confirmed on him by the Highways Act 1980 and the Acquisition of Land Act 1981 authorising the Authority to acquire the land specified in the Schedule hereto
- (2) Notice of the confirmation of the order was first published in accordance with Section 15 of the Acquisition of Land Act 1981 on 23 April 2019
- (3) That notice included the statement and form prescribed under section 15(4) (e) and (f) of the Acquisition of land Act 1981

NOW THIS DEED WITNESSETH that, in exercise of the powers conferred on them by section 4 of the Compulsory Purchase (Vesting Declarations) Act 1981 ("the Act"), the Authority hereby declare

- (1) The land described in the Schedule hereto (being part of the land authorised to be acquired by the order) and more particularly delineated on the plan annexed hereto, together with the right to enter and take possessions of the land shall vest in the Authority as from the end of the period of 3 months from the date on which the service of notices required by section 6 of the Act is completed.
- (2) For the purposes of section 2(2) of the Act, the specified period (in relation to the land comprised in the declaration) is one year and one day

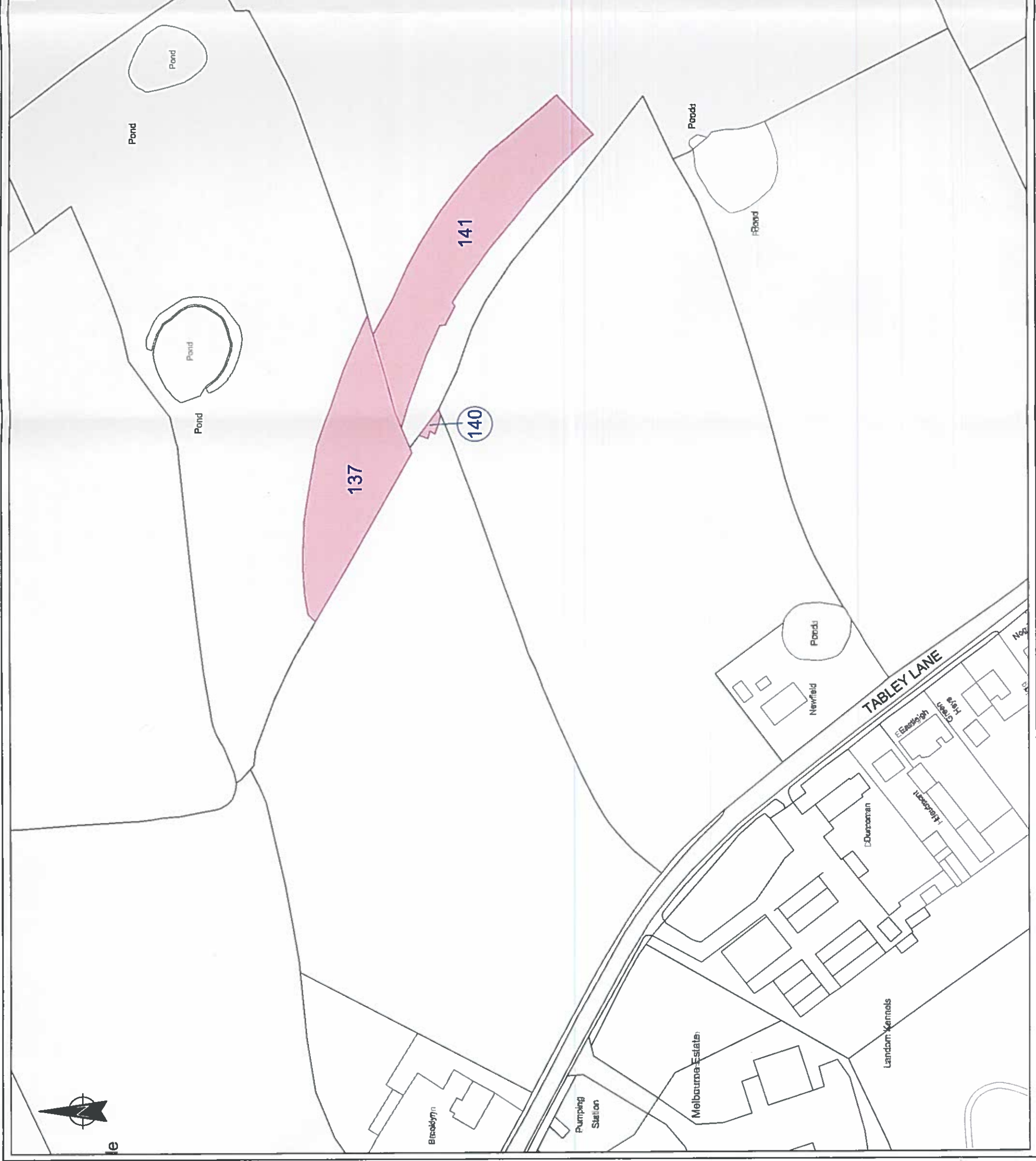
