## NOTICE OF PROPOSAL ROAD TRAFFIC REGULATION ACT 1984 LANCASHIRE COUNTY COUNCIL (RUFF LANE, ORMSKIRK, WEST LANCASHIRE) (ROAD HUMPS)

**NOTICE IS HEREBY GIVEN** that in accordance with Section 90A of the **Highways Act 1980**, Lancashire County Council propose to introduce road humps in the following locations:

- a) Ruff Lane, Ormskirk, from a point 40.3 metres southeast of its junction with the Centreline of Knowsley Road for a distance of 3.7 metres in the south easterly direction.;
- b) Ruff Lane, Ormskirk, from a point 160.1 metres southeast of its junction with the Centreline of Knowsley Road for a distance of 3.7 metres in the south easterly direction.;
- c) Ruff Lane, Ormskirk, from a point 269.8 metres southeast of its junction with the Centreline of Knowsley Road for a distance of 3.7 metres in the south easterly direction.;
- d) Ruff Lane, Ormskirk, from a point 367.7 metres southeast of its junction with the Centreline of Knowsley Road for a distance of 3.7 metres in the south easterly direction.;
- e) Ruff Lane, Ormskirk, from a point 481.3 metres southeast of its junction with the Centreline of Knowsley Road for a distance of 3.7 metres in the south easterly direction.;
- f) Ruff Lane, Ormskirk, from a point 585.4 metres southeast of its junction with the Centreline of Knowsley Road for a distance of 3.7 metres in the south easterly direction;
- g) Ruff Lane, Ormskirk, from a point 709.1 metres southeast of its junction with the Centreline of Knowsley Road for a distance of 3.7 metres in the south easterly direction.

The road humps will have a maximum height not exceeding 75mm.
