Summer Term 2022 Cycle

Some Schools Forum and Working sessions may offer physical meetings in the summer term 2022, for the first time since the pandemic, although the opportunity to join the meetings using 'hybrid' technology may also be offered to enable colleagues to also join remotely. The working groups will consider issues in June 2022 and recommendations to be presented to the Schools Forum in July. Amongst the main items to be presented are:

- The Schools Budget Outturn position for 2021/22
- Information on the level of individual school balances at 31 March 2022 and about clawback arrangements for March 2023
- The Schools Forum Annual report for 2022/23
- Amendments to the Lancashire scheme for financing schools and responses on the proposals
- Initial information about possible de-delegations and formula changes for 2022/23
- An update of the Early Years Funding Agreement 2022/23
- Responses to an early years sector questionnaire about current challenges facing the
- Consideration of the High Needs Block commissioned places process for 2022/23

Schools Budget 2022/23 (Income and Expenditure return)
