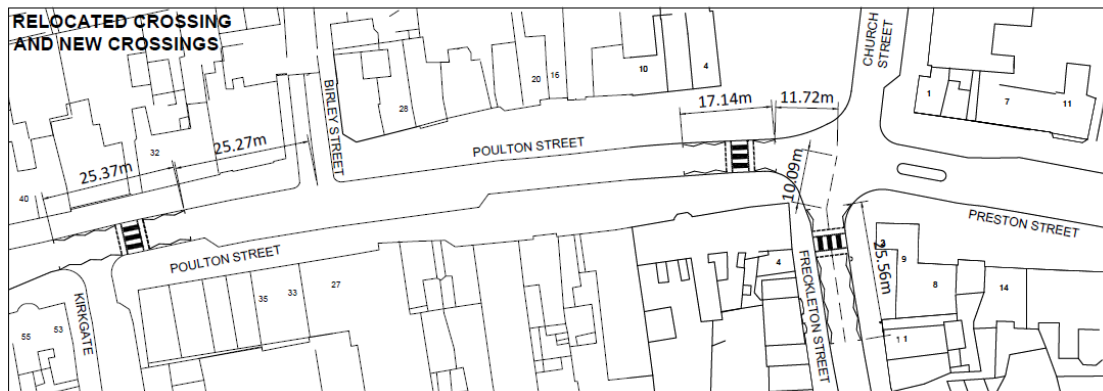
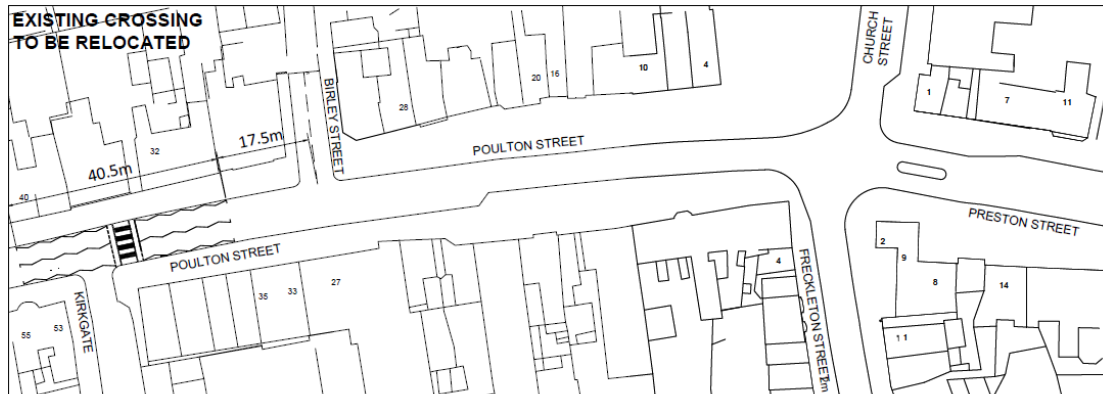


NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(FRECKLETON STREET AND POULTON STREET,
KIRKHAM, FYLDE BOROUGH) (PEDESTRIAN
CROSSING)



NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above pedestrian crossings under Section 23 of the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Remove a zebra crossing in Poulton Street, Kirkham, from a point 17.5 metres west of its junction with the centreline of Birley Street, for a distance of 40.5 metres in a westerly direction.
2. Introduce a zebra crossing in the following lengths of road:
 - a) Freckleton Street, Kirkham, from a point 10.09 metres south of its centreline junction with Church Street for a distance of 25.56 metres in a southerly direction;
 - b) Poulton Street, Kirkham, from a point 11.72 metres west of its centreline junction with Preston Street for a distance of 17.14 metres in a westerly direction;
 - c) Poulton Street, Kirkham, from a point 25.27 metres west of its junction with the centreline of Birley Street for a distance of 25.37 metres in a westerly direction.

Statement of Reasons

The proposals are for new zebra crossings on Freckleton Street and Poulton Street near Preston Street and the relocation of the existing zebra crossing on Poulton Street near Kirkgate as part of the Kirkham Public Realm improvements scheme. The two new zebra crossings and the relocated zebra crossing are being pursued to provide safe desirable crossing points for pedestrians and improving social inclusion for all users.

These proposals form part of a s278 Agreement under the Highways Act 1980 as part of the Kirkham Public Realm improvements scheme.
