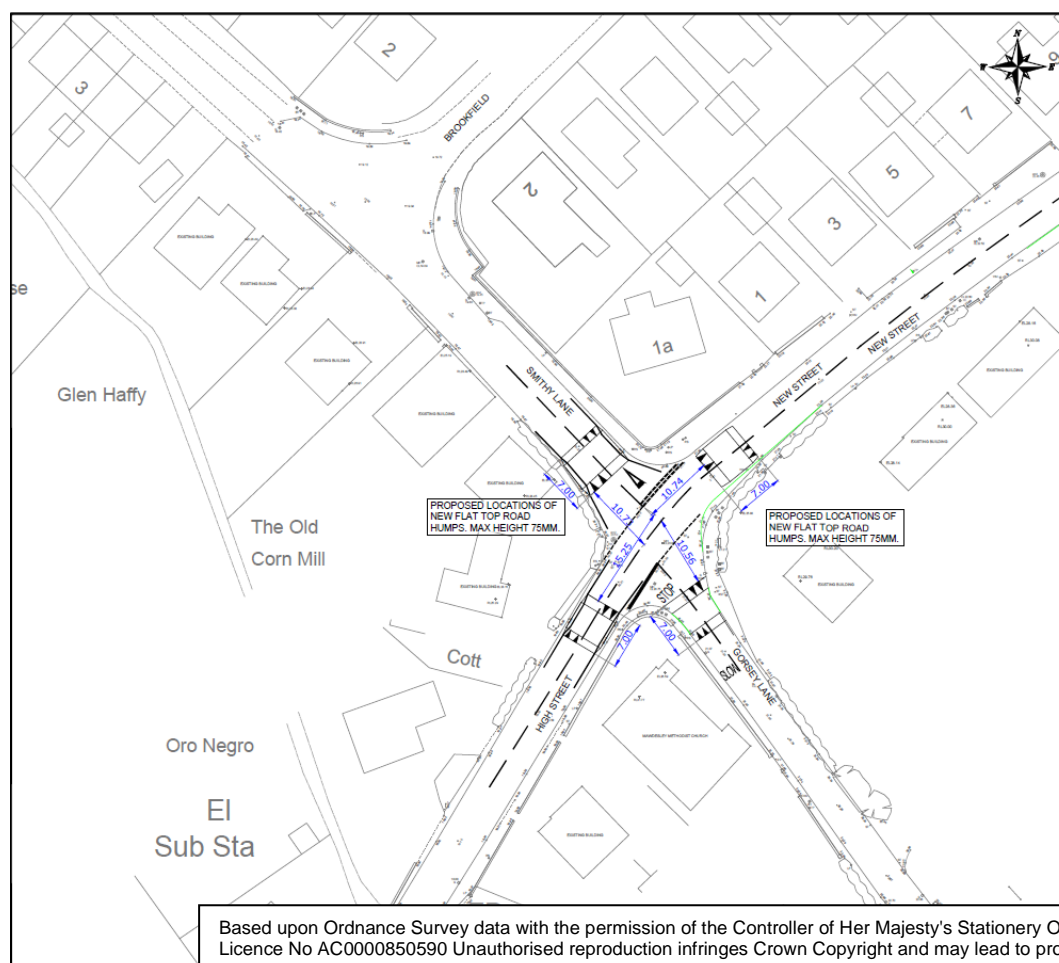
**(GORSEY LANE, HIGH STREET, NEW STREET AND
SMITHY LANE, MAWDESLEY, CHORLEY BOROUGH)
(ROAD HUMPS)**



NOTICE IS HEREBY GIVEN that in accordance with Section 90A of the **Highways Act 1980**, Lancashire County Council propose to introduce flat top road humps in the following locations:

- Gorsey Lane, Mawdesley, from a point 10.56 metres southeast of its junction with the centreline of High Street/New Street for a distance of 7 metres in a south easterly direction;
- High Street, Mawdesley, from a point 15.25 metres southwest of its centreline junction with New Street for a distance of 7 metres in a south westerly direction;
- New Street, Mawdesley, from a point 10.74 metres northeast of its centreline junction with High Street for a distance of 7 metres in a north easterly direction;
- Smithy Lane, Mawdesley, from a point 10.73 metres northwest of its junction with the centreline of High Street/New Street for a distance of 7 metres in a north westerly direction.

The road humps will have a maximum height of 75mm.



Statement of Reasons

The purpose of the proposed New Road Humps is to improve the safety of motorised and non-motorised users, helping to control the speed of approaching traffic at this busy crossroads location and to give drivers sufficient time to assess the layout helping towards safer navigation of the area.

The proposals form part of a s278 Agreement under the Highways Act 1980 as part of a new housing development off Gorsey Lane which will increase traffic and pedestrian movements along New Street, Gorsey Lane, High Street and Smithy Lane.
