



## **Park & Pedal - Terms and Conditions**

The Scheme is operated by Lancashire County Council Sustainable Travel Team. Bamber Bridge Football Club own the car park and have agreed to participate in the scheme by allowing the use of their facility.

By registering for membership of the Scheme, you signify that you have read, understood and agree to abide by the terms and conditions of use and any local site restrictions that may be specified by the site owner, whether listed on site or given verbally at the location.

### **Terms & Conditions**

Registration is necessary for anyone wishing to make use of the Park and Pedal scheme and facilities. Registration form is available by emailing [sustainabletravel@lancashire.gov.uk](mailto:sustainabletravel@lancashire.gov.uk) or telephoning 01772 530201.

Prior to first use of the Park and Pedal scheme a completed registration form must be received and approved by the Sustainable Travel Team.

All users completing the registration form must provide current, complete and accurate information. Failure to do so will invalidate your application.

You are responsible for informing the County Council of any changes to the information supplied particularly to vehicle or contact details by completing a new registration form.

By registering you agree to your details being stored and used for the sole purpose of safe operation and assessment of the scheme.

Decisions to accept registration requests are at the sole discretion of Lancashire County Council who reserve the right to refuse or suspend membership.

Registration is non-transferable or to be shared with any other party.

You agree to notify Lancashire County Council if you no longer intend to make use of the facility. You may cancel your registration at any time.

If the scheme is oversubscribed new registration requests will be put on hold until vacancies become available.

Lancashire County Council and/or Bamber Bridge Football Club reserve the right to amend, suspend or withdraw the scheme at any time without notice.

The Park and Pedal scheme is a shared facility, at busy times parking may not be guaranteed. Registration does not guarantee the availability of parking spaces.

All vehicles must be parked entirely within a marked bay, you must comply with all signs in the car park and respect other users

Access to Bamber Bridge Football Club is via an unsegregated entrance, extra care should be taken and priority given to pedestrians and cyclists using this access.

The car park is open to the public and no assurance can be given that people will not enter into the Car Park and cause damage to property or engage in criminal behaviour.

Vehicles are parked entirely at the registered user's own risk and neither Lancashire County Council nor Bamber Bridge Football Club accepts liability for any damage or loss occurring to vehicles and/or contents, other than that arising as a result of negligence on the part of the Council or the Football Club."

### **Data Protection and Privacy**

The County Council is the Data Controller of the information it holds about you. If you wish to amend this information or have any concerns regarding it please contact the County Council's Data Protection Officer.

The County Council will comply with the Data Protection Act 1998. We will use any personal information you provide us with only for the purposes for which you provide it. We will only hold your information for as long as necessary for these purposes and will not pass it to any third parties without your consent (other than location operators). The County Council employees who have access to your personal data and are associated with the handling of that data, are obliged to respect the confidentiality of your personal data. The County Council employees referred to in this clause shall be restricted to those involved in the administration and running of the Scheme.
