ACCRINGTON) COMPULSORY PURCHASE ORDER 2019

This GENERAL VESTING DECLARATION is executed on the 4TH day of OCTOBER 2019 by Lancashire County Council (the Authority).

WHEREAS:

1. On the 19th June 2019 an order entitled the Lancashire County Council (Church Gateway – Junction Improvement at market Street and Blackburn Road, Church, Accrington) Compulsory Purchase Order 2019 was confirmed by the Secretary of State for Transport under the powers conferred on him by the Highways Act 1980 and the Acquisition of Land Act 1981 authorising the Authority to acquire the land specified in the Schedule hereto.
2. Notice of the confirmation of the order was first published in accordance with section 15 of the Acquisition of Land Act 1981 on the 26th July 2019.
3. That notice included the statement and form prescribed under section 15(4)(e) and (f) of the Acquisition of Land Act 1981.

NOW THIS DEED WITNESSETH that, in exercise of the powers conferred on them by section 4 of the Compulsory Purchase (Vesting Declarations) Act 1981 (the Act), the Authority hereby declare:

- 3.1 The land described in the Schedule hereto (being part of the land authorised to be acquired by the order) and more particularly delineated in red on the plan annexed hereto, together with the right to enter and take possession of the land shall vest in the Authority as from the end of the period of 98 days from the date on which the service of notices required by section 6 of the Act is completed.
- 3.2 For the purposes of section 2(2) of the Act, the specified period in relation to the land comprised in the declaration is one year and one day.

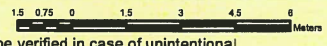

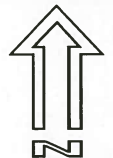
