## **RE: Covid-19 (Coronavirus)**

The spread of coronavirus is a serious concern across the country, and we are living in unprecedented times. We are following advice to try to reduce the risk of infection and to minimise the risk to people who may be especially vulnerable. I am writing to offer some information and advice about how we are managing support for Lancashire residents who rely upon it.

Covid-19 may result in high levels of staff sickness impacting on the people who employ personal assistants or purchase support from care providers. The Council is working closely with the Lancashire Independent Living Service (LILS) to ensure that people in receipt of direct payments are supported to manage their care arrangements.
