This issue deals with matters to be considered at the summer term 2020 cycle of meetings.

COVID-19

The Schools Forum is continuing to operate during the current COVID-19 pandemic, although no face-to-face meetings are taking place, and business is being conducted using alternative means. In order to approve actions needing urgent attention due to the current coronavirus situation, the Forum has supported policy and operational changes using their Urgent Business procedure. Agreed changes have included:

- A Supply Cover Insurance policy update has been agreed, which will allow schools to claim for staff
 that are self isolating or shielding, where the school can demonstrate that they are incurring additional
 costs which could not be met by other flexible working options available at the current time. Under
 normal operation, the scheme only reimburses schools for sickness absence. Further information is
 available here
- DfE have cancelled the May 2020 school census and alternative data sources have been agreed with school representatives and the Forum to enable summer term funding redeterminations to be calculated. Slightly different methodologies have been agreed for different sectors, to reflect the needs of each phase. Arrangements are now taking place to collect and calculate the data.

Summer Term 2020 Cycle

The Forum Working Groups, will consider issues in June 2020 and recommendations to be presented to the Schools Forum in July. Amongst the main items to be presented are:

- The Schools Budget Outturn position for 2019/20;
- Information on the level of individual school balances at 31 March 2020 and about clawback arrangements for March 2021;
- The Schools Forum Annual report 2019/20;
- Amendments to the Lancashire scheme for financing schools;
- Initial information about possible de-delegations and formula changes for 2020/21
- Possible reimbursement of some de-delegated funding to schools.

"Schools Financial Value Standard"
