Recap on Finance and PPE arrangements Ian Crabtree



Infection Prevention Control Grant – recap from last week's webinar and previous tranche

- Existing IPC Grant arrangements and spending period come to an end 30th Sept 2020
- LCC's allocation in the first ICF tranche was £16,197,303, of which £12,619,000 was allocated to care home (75%)
- The remaining 25% was allocated to domiciliary care, supported living, day services, etc
- The government's Winter Plan announcement confirms that **new IPC Grant arrangements** have been established to take providers through until 31 March 2021



Infection Prevention Control Grant -Tranche 2 - update

- Lancashire will be receiving £14,883,462 in total
- 80% of each instalment must be shared on a 'per bed/per user' basis to domiciliary care, extra care and supported living providers, as well as care homes
- £8,509,183 of this amount is for allocation to care homes
- £3,397,587 of this amount is for allocation to community care providers
- The other 20% (discretionary funding) £2,976,692- will be used to support the full range of social care providers regardless of whether the local authority already commissions care from them;
- If care homes have unoccupied beds we can add their unallocated monies to the 20% discretionary pot, we can do the same if providers hand back their allocation;
- We can use the 20% discretionary element to fund/buy PPE.

Financial Assistance Scheme

- LCC's own financial scheme to support providers since April 2020
- About £6m spent on extra costs
 - Mostly on staffing costs
 - PPE
 - Other equipment
- In light of earlier points on PPE and IPC we will be winding this Financial Assistance scheme up completely in next fortnight
- We will write to confirm arrangements in w/c 5th October



PPE - new arrangements National PPE Portal

- National PPE Portal is <u>the</u> main supply route
 - Free PPE for all CQC registered care providers
 - Providers must register but then can order what they need
 - Volumes of items issued reflect calculations based on standardised assumptions about need and usage
 - Delivery by Royal Mail
 - <u>PPE Portal (link)</u>

PPE - new arrangements LCC role

- LCC no longer to be a routine supplier of PPE to registered care providers
- LCC will be the supplier to day services, PAs, social work, OT staff etc – ie non CQC registered care providers – this will be via supplies from National PPE Portal
- LCC still maintaining a strategic stockpile in case of further national / international supply chain disruption



PPE - new arrangements Providers own supply chains

- Providers can of course continue to buy their own PPE
- However costs will no longer be reimbursed by LCC from 1st October 2020
 - LCC not receiving further money from Government to cover
 PPE costs –
 - so can't afford to continue to meet providers costs



IPC Update (Ellen Smith)

Updated 28th September to reflect retesting exemption of staff from 6 weeks to 90 days if they have not developed new COVID like symptoms.

Guidance COVID-19: management of staff and exposed patients or residents in health and social care settings

Updated 28 September 2020

Retesting Staff

- Staff who have previously tested positive should be exempt from being re-tested within 90 days from their initial onset, unless they develop new COVID symptoms.
- This is because fragments of inactive virus can be persistently detected.
- If after 90 days, staff are tested and found to be positive, this should be considered as possible new infection.



Reminders

- Reports of PPE not being worn correctly, in particular masks moved to chin area.
- If mask is touched or removed for whatever reason then it must be replaced.
- Please ensure all staff have PPE refresher training by watching the donning and doffing videos.
- Correct techniques are there to protect you.
- Hand hygiene and socially distancing are still key.



Reminder: Outbreak definition (Ellen Smith)

- An outbreak is defined as two or more confirmed cases (staff or resident) of COVID-19 OR clinically suspected cases of COVID-19 among individuals associated with a specific setting with onset dates within 14 days.
- An incident is defined as less than 2 people with suspected Covid-19 (regardless whether staff or residents).
- No test-confirmed cases with illness onset dates in the last 28 days in that setting = end of outbreak



Message on behalf of PHE North West Health Protection Influenza Leads

- The PHE North West Health Protection Team has received a number of enquiries from CCGs and Primary Care regarding flu vaccination in care homes if residents are symptomatic or asymptomatic of covid-19.
- North West NHS England-NHS Improvement Screening and Immunisation colleagues have raised this with the national team and have received guidance.



Message on behalf of PHE North West Health Protection Influenza Leads

- If a care home has an outbreak or cases of COVID-19, then any decision to vaccinate against influenza would need to be informed by a risk assessment.
- The process around risk assessments and roles is being discussed at the LRF.
- The risk assessment should take into account: -
- Number of symptomatic acutely unwell residents in the care home
- Number of positive symptomatic and positive asymptomatic residents in the care home
- Proximity of cases to other residents who require flu vaccination
- IPC measures in place and appropriate PPE available for immunisers

Free iPads for Care Homes

- <u>NHS is offering iPads to help care homes and</u> <u>residents</u>
- Offer includes:
 - Data-enabled SIM cards for homes with poor Wi-Fi
 - Video consultations with health and care professionals
 - Access to secure NHS email service



Which care homes can apply?

- Homes that receive some or all of their funding from the NHS or a local authority
- Have less than one tablet device per 40 residents
- <u>Apply for a device using the NHS online</u> <u>order form</u>
