




Expenditure Service Analysis






Income Analysis

Covid-19 Considerations

- Unique Challenge
- Impact on every aspect of the election process.

Who does what at the County Election?

- Returning Officer
- Deputy Returning Officer
- Electoral Registration Officer
- District Elections Managers/Teams



Who can stand for the County Election?

- Over 18
- British Citizen, Commonwealth or European Union Citizen and/or
- Registered elector in Lancashire, and/or
- Occupier as owner/tenant of property/land in Lancashire, and/or
- Work in Lancashire, and/or
- Live in Lancashire



Who can't stand for the County Election?

- Employed by County Council
- Politically Restricted Post
- Bankrupt
- Sentenced to a term of imprisonment
- Provisions under the RPA Act



Standing as a Candidate

- Nomination Form
- Full Name
- Home Address Form
- Description [usually name of political party]
- Signatures of 10 Registered Electors for the Division
- Consent to Nomination
- Certificate of Authorisation
- Request for use of Political Emblem



Standing as a Candidate

- Take care when completing your nomination papers, as mistakes may invalidate your nomination
- Complete nomination papers early and arrange for us to provide an informal check
- Nomination papers must be delivered in person
- Where and when



Standing as a Candidate

- Withdrawing your Nomination
- Appointing Election Agents
- Other Agents: Postal Vote Agents, Polling Agents, Counting Agents



The Campaign

- As a candidate you are uniquely placed to encourage people to register to vote.
- You should encourage people to register as soon as possible.
- Registration changed from a household system to an individual system in 2014. Individuals can now also register online at https://www.gov.uk/register-tovote. It only takes a few minutes.



The Campaign

- You must ensure that all campaign material includes the name of the printer and promoter
- On Polling Day make sure your tellers follow the Electoral Commissions guidance "tellers do's and don'ts"
- Make sure all your agents attending postal vote opening sessions, polling stations and the count understand the secrecy requirements
- The Returning Officer is there to run the Election not act as referee between Candidates

- Postal vote opening
- Postal Vote Agents
- Polling Stations
- Polling Agents
- The Count
- Counting Agents



Spending and Donations

- How much you can spend on your election campaign (known as expenses) is limited and your expenditure must be accurately recorded – (£806 + 7 pence per elector in division)
- The period that you must record any expenditure is from Notice of Election until close of Poll



Spending and Donations

- Returns due 35 calendar days after result of election
- Returns made public by Deputy Returning Officer
- Sample of returns may be reviewed by the Electoral Commission
- Failure to submit an expenses return is a criminal offence enforceable by police
- No spending will be reimbursed

"Candidates spending is often known as "expenses". Sometimes, people think this means that this spending can be reclaimed from us after the election. This is not the case!"
