The Definitive Map and Statement of Public Rights of Way for the County of Lancashire The Lancashire County Council Definitive Map and Statement of Public Rights of Way Public Footpath from Banks Road to Station Road, North Meols, West Lancashire Borough (Definitive Map Modification) Order 2014

On behalf of Southport Land and Property Company Limited, the current owners of the land affected by the above Modification Order, we submit the following objection.

The Order cannot be confirmed because:

- 1. There is little if any mapping or other evidence to support the existence of the section from A-C (that part running south from Banks Road) on the ground. If the use alleged had occurred then there would be physical evidence of its existence.
- 2. Such use that may have occurred is at such a low level so that the presumption of dedication cannot arise. This is consistent with the evidence of the owner of the property adjacent to point A who in more than 45 years has not witnessed any use of the alleged route, and that such use has produced no physical evidence that it has occurred.
- 3. The route was claimed by the Parish Council and found not to be a public right of way in 1955. Since that date despite having the opportunity to seek its recording, the Parish Council has not done so.
- 4. Taken as a whole the evidence in support of the claim fails to satisfy the burden on the County Council to prove that a right of way exists on a balance of probabilities.
- 5. There is no evidence that any landowner has ever demonstrated an intention to dedicate so that common law dedication cannot be proved.

For the above reasons our clients object to the confirmation of the Order and they will further particularise their grounds of objection in their Statement of Case in response to that submitted by the County Council.

Kindly acknowledge receipt of this objection and confirm that the Order will be submitted to the Secretary of State for determination.



Whilst I strongly support Banks/ North Meols Parish Councils efforts to have this route and others in the locality – Station Road to Banks Road reopened and accorded a definitive status, I feel that I must object to the Modification order for Footpath status.

I have known of this route and its usage for over 50 years. Vehicles, horses, cyclists and walkers all used the route which provided direct access away from the main road from one side of the village to the other, until "cut off" at Banks Road end circa 1990.

It would be a missed opportunity for the Banks and Hesketh Bank communities for this route not to have a HIGHER STATUS recognised. I feel that Bridleway Status affording Multi- Purpose use would be an invaluable road safety asset.

This historical route – formerly used by working horses and carts for Southport Shrimpers and Fishing activities directly links to Bridleway Nos 47 and 48 at Banks Road and is very close to the new Sefton Cycleway route (avoiding dangerous main road junction at the Plough Roundabout).-taking users along the coastal road route to Southport.

The Station Road entrance to this route (which already affords vehicular access) is only a short distance from the old station at Banks Village where the disused rail track is a concessionary bridleway route – already widely used by horse riders and walkers etc. To access quieter country lanes or ultimately if required to the other end of Bridleway Nos 47- 49 thereby providing a Circular Route around the village perimeter, avoiding the more congested village centre.

I understand that further user evidence is being presented to you and that serious consideration can be given to Bridleway recognition for this historic and much needed route.

Re: Wildlife & Countrytside Act 1981- Part111 claim for definitive map modification order claimed Public footpath from Banks Rd (Ralphs Wife Lane?) to Station Rd, north Meols, West Lancs

With reference to the above we wish to make an appeal against the Modification order for several reasons

We have previously notified you that we have lived at the above address since 1970 and the adjacent field where the proposed foot path is meant to be as never had public access. Originally it was used as a pasture for grazing cattle .Later it was used for general agriculture for several years and now it is currently used for grazing sheep and occasionally for a Car Boot sale.

We and our neighbours have several concerns regarding the issue.

Firstly – the approach on to Banks Rd is directly on to a blind corner and is a 40mph speed limit. There has been several accidents over the years we have lived here. Therefore we feel it would be a danger to the general public

Secondly- our privacy will be compromised with the public having an easier access to our back gardens

Thirdly - there has been several occasions when cars have tried to drive from Station Rd to Banks Rd.

Fourthly- there is the health & safety issue of walking along the bank of The Sluice due to its depth and steep sides.

We would like to stress yet again there has never been a public access all the years we have lived in the area
