**NOTICE IS HEREBY GIVEN** that Lancashire County Council proposed to make the above Traffic Regulation Orders under Sections 1, 2, 4, 45 and 46 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended. Following consultation carried out between 06 October 2021 and 03 November 2021, it is now intended to modify the proposed Orders as titled above, as set out below.

Amend Schedule 2 to increase the Maximum Allowed Visitors Permits for LBC to 56 as set out below

**Statement of Reasons**

The purpose of the modification is to increase the maximum amount of permits for the LBC Zone in proposal 894.13947 from 40 permits to 56 permits to allow for 16 permits for the HM Coastguards that were missed from the initial proposal. The modification also adds the HM Coastguards to the eligible properties for the LBC Zone in proposal 894.13808
