Keyworker Team update

Recruitment - 3 unsuccessful rounds of advert for Band 7 and Band 5 roles.

Business Case has been put forward to request permanent roles.

Two **new staff** started at the start of August - inductions have taken place. Team have now moved into Greenbank - still in process of going live as a **base**.

Since April/May we have been involved with **25 Cases**/ 4 are stepped down/ 8 are oversight and distant support/13 active cases in the early stages of support.

The team are starting to see some themes from the individual support they have been involved in. Suggestion to have a workshop in the future to look at action learning sets on these themes
