# 1. Welcome and Apologies

Dr Julie Higgins, Chair, welcomed attendees to the meeting. Apologies were noted.

# 2. Standing Items

## 2.1 Minutes From 16 September 2021 Meeting

Minutes received by all members prior to the meeting. Approved by the board as written.

## 2.2 Action Tracker

Action tracker received by all members to review before the meeting. All actions from previous meeting noted as complete or on the meeting agenda.



#### 3. Improvement Progress

#### 3.1 Update from DfE monitoring of Accelerated Progress Plan

Edwina Grant OBE, Executive Director of Education and Children's Services was pleased to report that following the final monitoring meeting all five outstanding actions had been met and could remit to normal service. Edwina noted that the SEND reviews had hit a rhythm and that a useful reporting system had been developed (for future use). Edwina felt it was important to note that all those involved had performed well and she was proud of all the partners who had played a part during a very difficult period whilst dealing with covid. It was further noted that Lancashire County Council was above statistical neighbours for EHCPs and the rates of improvement were bucking trends.

Chair agreed with Edwina's comments and added her congratulations. Chair noted that it was testament to those involved that, whilst dealing with covid, a real difference had been made. Kieran Welsh, Lancashire Special Schools Head Teachers Association, noted the letter of thanks from Edwina that had been circuated had landed very well with staff.

#### 3.2 Review of SEND Plan 2021-2025 and proposed new governance structure

Zoe Richards, Senior Manager for SEND for Health introduced a governance plan. It was suggested that following coming out of the monitoring meetings, Partnership Board meetings should be held on a quarterly basis with the SEND Operational Group being renamed SEND Executive Group (chaired by Hilary Fordham and Julie Bell) meeting monthly, providing checks and challenges and report to the board. Following discussion the board agreed to meet on a quarterly basis.

**ACTION**: SEND Partnership Board to be arranged quarterly for 2022

Zoe shared the proposed SEND Governance Structure. Edwina asked that co-design be added to the diagram, asked the children and young people be added and for Parent Carer Champions be moved from the bottom of the diagram. Edwina noted that the structure would ensure that the right decisions would be brought back to the board.

Lorna Harris, Youth Support advised that the young people had been over the moon to be engaged with the board and to see tangible change. Lorna added their thanks for being allowed to take part in the meetings. Zoe would be invited to a meeting on the 11 January by Olly Moores, Chair Children and Young People SEND Board.

Dave Carr, Director of Policy, Commissioning and Children's Health shared a slide entitled Delivering the Lancashire SEND Plan 2021-2025, detailing a high level plan with five ways of working and five priorities. He advised this was a dynamic framework that allowed the partnership to grow and develop together. Additionally, Dave acknowledged that there was a lot of activity and it would be a challenge to stitch together (business as usual; ongoing development; tools and enablers). Operational Group (to be renamed Executive Group) to be responsible for aligning activities to governance arrangements with oversight of project delivery. Chair noted that the diagram was a useful tool.

# 4. Key Topics (Specific topics related to the improvement plan and the SEND Code of Practice)

#### 4.1 DCO 6 Monthly Report

Anne Hardman, Designated Clinical Officer introduced the Designated Clinical Officer Team Bi-Annual Report which had already been circulated to the group. Anne noted that there had been a massive increase in EHCP requests as well as improving return rates.

It was widely agreed that the case study was an excellent example of the most common issues/themes. Sam Jones, Chair of the Lancashire Parent Carer Forum added that the issues raised were national, and did not only apply to Lancashire.

Dave Carr advised that it would be interesting to work together to look at the Early Help pathways and governance and create a multi-disciplinary pathway. It was agreed that working together with peers would strengthen knowledge, feedback and participation.

Maria Hall, a Community Paediatrician, and Community Health Representative suggested that medical management in schools needed to be addressed which in part came down to staffing issues, the timing of paediatric reviews and the prioritisation of medical emergencies.

Nighat Parveen, Senior Manager Strategic Lead 0-11 yrs (Early Help) explained that there were some gaps in Early Help but work was taking place to pinpoint service blockers around access to specialiast services and an e-learning package was being put together.

#### 4.2 SEND IAS 6 Monthly Report

Laura Morris, IAS Team Manager, Lancashire County Council gave a presentation on the six monthly update (April to September 2021) on Lancashire SEND IAS which had previously been circulated. Chair noted her congratulations for the national recognition for the joint commissioning approach adopted in Lancashire. Laura noted that the average number of calls had increased and a meeting was planned with Business Intelligence to dig deeper into the data.

Laura confirmed that she had received the feedback from the young people, which had been really useful around anxiety support. A link would be added to the website for self-referral.

Zoe Richards noted that the presentation demonstrated the way teams were working together now, joining up conversations. Chair agreed that the multi-disciplinary work was working well.

#### 4.3 LCPF 6 Monthly Report

Sam Jones, Chair of the Lancashire Parent Carer Forum, gave a presentation on the Lancashire Parent Carer Forum which had been circulated. Sam noted that it had been difficult to increase involvement and attendance over the last two years because of covid, however she welcomed the partnership's move from silo working to joint approaches. She also noted that the next steps for the parent carer forum was to increase forum capacity and training of the forum members, with a recruitment drive designed to achieve one trained parent carer representative for each of the 12 districts. This team would then be able to work co-operatively within the PCF and across the partnership.

Zoe Richards asked the group to remember the agreed vision, 'think SEND, think voice' and to always consider whether we have heard the voice of children, young people and carers.

Edwina added that she liked the idea of co-design, i.e. 'you said, we did' but the partnership needed to get better at it and increase motivation. It would be useful to see if digitisation helps.

**ACTION:** The SEND Partnership Board to support the Lancashire Parent Carer Forum to attract and develop more representatives from across Lancashire

Zoe Richards noted that Sally Nightingale had been invited to the next meeting to discuss learning disabilities and autism, including keyworking function, Autism in Schools Project and LandSCAPE (Lancashire and South Cumbria Autism and Project Evaluation).

The focus for young people was on co-production, opportunity and sharing their voice of power. It was suggested that a certification of their support and involvement would be useful and the opportunity to celebrate their achievements.
