

**NOTICE OF PROPOSAL**  
**ROAD TRAFFIC REGULATION ACT 1984**  
**LANCASHIRE COUNTY COUNCIL**  
**(UNITY WAY, RAWTENSTALL, ROSSENDALE BOROUGH) (REMOVAL**  
**AND INSTALLATION OF ROAD HUMPS)**

**NOTICE IS HEREBY GIVEN** that in accordance with Section 90A of the **Highways Act 1980**, Lancashire County Council propose the following:

- 1) Remove road humps in the following locations:
  - a) Unity Way, Rawtenstall, the western arm, from approximately 23 metres north from its centreline junction with Haslingden Old Road for a distance of 5 metres, at a maximum height 75 millimetres;
  - b) Unity Way, Rawtenstall, the western arm, from approximately 58 metres north from its centreline junction with Haslingden Old Road for a distance of 5 metres at a maximum height 75 millimetres;
  - c) Unity Way, Rawtenstall, the eastern arm, from approximately 29 metres north from its centreline junction with Haslingden Old Road for a distance of 5 metres at a maximum height 75 millimetres;
  - d) Unity Way, Rawtenstall, the eastern arm, from approximately 66 metres north from its centreline junction with Haslingden Old Road for a distance of 5 metres at a maximum height 75 millimetres;
  - e) Unity Way, Rawtenstall, the northern arm, from approximately 117 metres north west from its centreline junction with Haslingden Old Road for a distance of 5 metres at a maximum height 75 millimetres.
- 2) Introduce flat top road humps with uncontrolled crossing points in the following locations:
  - a) Unity Way, Rawtenstall, the western arm, from a point approximately 20 metres north from its centreline junction with Haslingden Old Road for a distance of 5 metres at a maximum height 75 millimetres;
  - b) Unity Way, Rawtenstall, the western arm, from a point approximately 68 metres north from its centreline junction with Haslingden Old Road for a distance of 5 metres at a maximum height 75 millimetres;
  - c) Unity Way, Rawtenstall, the eastern arm, from a point approximately 42 metres north from its centreline junction with Haslingden Old Road for a distance of 5 metres at a maximum height 75 millimetres;
  - d) Unity Way, Rawtenstall, the northern arm, from a point approximately 115 metres north west from its centreline junction with Haslingden Old Road for a distance of 5 metres at a maximum height 75 millimetres.
