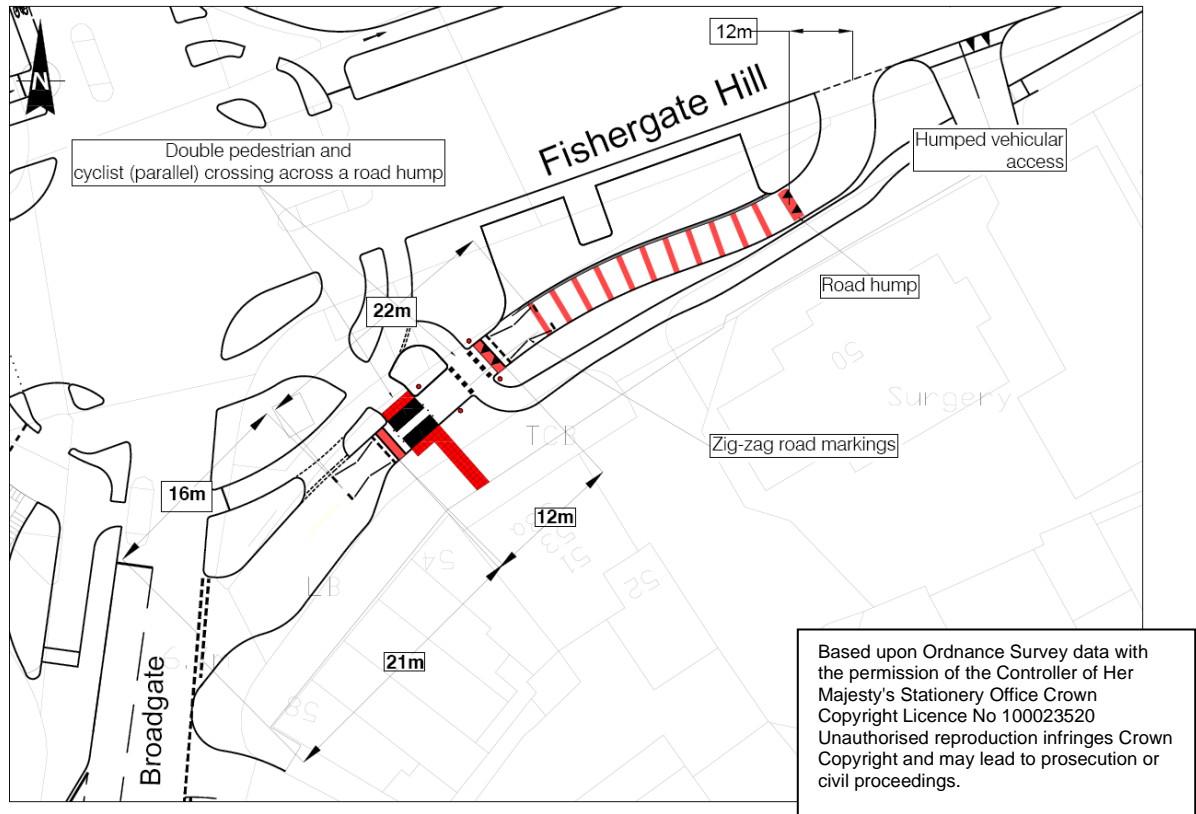


NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(FISHERGATE HILL (U4369 and C329), PRESTON, PRESTON
CITY) (PARALLEL CROSSING AND ROAD HUMPS)

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above under Section 23 of the **Road Traffic Regulation Act 1984**, as amended, and Section 90A of the **Highways Act 1980**, the effect of which will be to:

1. Introduce a parallel crossing in Fishergate Hill (U4369), Preston, from a point 16 metres north east of its junction with Broadgate, for a distance of 22 metres in a north easterly direction.
2. Introduce a road hump for the parallel crossing, in Fishergate Hill (U4369), Preston, from a point 21 metres north east of its junction with Broadgate, the full width of the carriageway, for a distance of 12 metres in a north easterly direction, at a maximum height of 40 millimetres.
3. Introduce a round top road hump in Fishergate Hill (U4369), Preston, from a point 12 metres south west of its junction with Fishergate Hill (C329), the full width of the carriageway, for a distance of 0.9 metres in a westerly direction at a maximum height of 40 millimetres.
4. Introduce a humped vehicular access in Fishergate Hill (C329), Preston, from its junction with Fishergate Hill (C329), the full width of the carriageway, for a distance of 10 metres into the Fishergate Surgery Car Park, at a maximum height of 100 millimetres.



Statement of Reasons

It is proposed to reduce the speed limit on Fishergate Hill (U4369) to 20mph in line with the surrounding streets and introduce a round top road hump, as such the lower speed limit will reduce the potential for accidents and improve general road safety. In addition, it is also proposed to install a Humped vehicular access at the junction of Fishergate Hill (C329) for access to Fishergate Hill Surgery.

To increase the safety of pedestrians and cyclists travelling through Broadgate junction whilst maintaining access to businesses on the south east of the junction, it is proposed to introduce a double pedestrian and cyclist (parallel) crossing on Fishergate Hill (U4369).
