ROAD TRAFFIC REGULATION ACT 1984 LANCASHIRE COUNTY COUNCIL

(GARSTANG ROAD, WHITTINGHAM LANE AND WOODPLUMPTON LANE, PRESTON, PRESTON CITY) (REVOCATION AND INTRODUCTION OF 20MPH AND 40MPH SPEED LIMITS) ORDER 2017

The County Council of Lancashire, in exercise of its powers under Section 84 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Revocation

Those parts of the "Lancashire County Council (Garstang Road, Whittingham Lane, Woodplumpton Lane, Newsham Hall Lane, and Langley Lane, Preston, Preston City) (Part Revocation, 30 mph and 40 mph Speed Limit) Order 2014", as set out in Schedule 1 to this Order, are hereby revoked.

2. 20mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 20mph on any of the lengths of road as set out in Schedule 2 to this Order.

3. 40 mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 40mph on the length of road as set out in Schedule 3 to this Order.

4. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.

5. Commencement of Order

This Order shall come into force on the 4th day of December 2017 and shall be cited as the "Lancashire County Council (Garstang Road, Whittingham Lane And Woodplumpton Lane, Preston, Preston City) (Revocation And Introduction Of 20mph And 40mph Speed Limits) Order 2017".

Schedule 2 - 20mph Speed Limit

- a) Whittingham Lane, Preston, from its centreline junction with Garstang Road to a point 16 metres north east of its centreline junction with Willow Tree Avenue.
- b) Woodplumpton Lane, Preston, from its centreline junction with Garstang Road to a point 8 metres south west of its centreline junction with Kingsway Avenue.
- c) Garstang Road, Preston, from its southerly junction with the A6 Broughton Bypass, in a northerly direction, to a point 421 metres north west of the centreline junction to Garstang Road with Whittingham Lane (B5269).

Schedule 3 - 40mph Speed Limit

Garstang Road, Preston, from a point 16 metres north of the circulatory carriageway of the A6 Broughton Bypass roundabout, in a northerly direction to a point 90 metres south of its junction with St Michaels Road.
