- Personal care tasks such as the administration of prescribed medication or the provision of support to passengers who require physical or medical intervention.

## Skills, knowledge and experience

- Experience or the ability to demonstrate the competence to carry out of the job.
- Possession of, or the ability to demonstrate the capability to gain, relevant certificates of competence or equivalent where applicable.
- The ability to work without close supervision.

In addition to the skills, knowledge and experience described above, you may be required to undertake a lower graded role as appropriate.

- 8. Acting in a general supervisory capacity with students and volunteers
- 9. Assisting with laundry duties and care of client's items including emptying and cleaning commodes, making and changing beds, cleaning and tidying lockers
- 10. Caring for the dying and attending to the needs of the deceased person and their relatives
- 11. Assisting management with the administration of medication
