Room Premium	<p>The annual fund for compliant room premiums remains at £10 per room per week for all new placements. It is the Provider's responsibility to ensure that the room premium is applied for and set up at the time the placement is made. Should a Provider make a later claim for room premiums, this should be via the Provider Portal, using the change request function. A room premium notification can be backdated up to a maximum of 3 months after the start date of placement (or room change) otherwise the premium will be paid from the date applied for.</p>			
Out of County Placements	<p>To avoid distorting prices in neighbouring council areas, the uplifts described in this report will not be applied to placements made outside of the county council's borders.</p> <p>Instead, the county council will honour the host authority uplifts, upon receipt of confirmation of the host authority uplift. The Provider is required to notify contractmgmt.care@lancashire.gov.uk within 3 months of the host authority uplift date being notified to the provider, for the full uplift to be applied. Notifications after 3 months will have the host authority uplift applied from date of request.</p>
