

PRESTON CITY COUNCIL
CITY OF PRESTON
(WELLFIELD ROAD AND MARSH LANE)
(COOPER ROAD ZONE) AMENDMENT ORDER 2006

WHEREAS

- (1) The Preston City Council pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Lancashire County Council may exercise certain of the powers possessed by the said County Council as the Highway Authority for the City of Preston.
- (2) The Council is satisfied that vehicular traffic in the roads specified in the Order should be restricted in the manner set out in the Order in the to maintain the free flow of traffic.

NOW THEREFORE the Council in exercise of the powers of the said County Council under Sections 1, 2, 4,45, 46, 49, 53 and 124(1)(c)(d)(f) of and Parts III, IV and VI of Schedule 9 to the Act of 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police for Lancashire hereby makes the following Order.

Commencement and Citation

1. This Order shall come into operation on the 27 day of April 2006 and may be cited as the "City of Preston (Wellfield Road and Marsh Lane) (Cooper Road Zone) Amendment Order 2006".

Interpretation

2. (1) In this Order:-

"the Act of 1984" means the Road Traffic Regulation Act 1984;

"the Council" means the Council of the City of Preston;

"vehicle" means a goods vehicle, an invalid carriage, a motorcycle, a motor vehicle, or any other vehicle of any description if drawn or propelled along a road by animal or mechanical power including a bicycle, a tricycle or a cycle having four or more wheels;

(2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

(3) The conditions, provisions, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other such matter imposed by any Order or regulation made, or having effect as if made, under the Act of 1984, or by or under any other enactment.

3. This Order amends the provisions contained in the Traffic Regulation Orders specified in the Schedule to this Order to the extent described in the said Schedule.

THE SCHEDULE

To amend the following parts of the below mentioned Orders

The Borough of Preston (Cooper Road Zone) (Parking Places and Traffic Regulation) Order 1993.

1. With reference to Article 22 and Schedule 3 thereto (Waiting Limited to 2 hours with return prohibited within 2 hours 8.00am – 6.00pm Monday to Saturday), delete the following:-

Wellfield Road - between points 40 metres and 52 metres north of
(east side) Lodge Street.

2. With reference to Article 26 and Schedule 4 thereto, the Schedule reads –

“To amend the following parts of:

The Borough of Preston (Various Roads) (Prohibition and Restriction of Waiting) (No. 1) Order 1975

Amend the First Schedule reference to Wellfield Road to read:

West Side	Whole Length
East Side	From Marsh Lane to a point 10 metres north of Lodge Street from a point 52 metres north of Lodge Street to Pedder Street”

To amend the following parts of:

The Borough of Preston (Various Roads) (Prohibition and Restriction of Waiting) Order (No. 1) 1975

Amend the First Schedule reference to Wellfield Road to read:-

Wellfield Road - full length
(West Side)

Wellfield Road - from Marsh Lane to a point 10 metres north of Lodge
(East Side) Street.

Wellfield Road - from a point 56 metres north of Lodge Street to
(East Side) Pedder Street.

3. With reference to Article 3 and Schedule 1 thereto (Areas of Highway or Parts of Highway Designated as Parking Places with Permits), the Schedule with regard to Wellfield Road (east side) reads:-

Wellfield Road - between points 10 metres and 40 metres north of
(east side) Lodge Street.

With regard to Wellfield Road, amend Schedule 1 to read:-

Wellfield Road - between points 10 metres and 56 metres north of
(east side) Lodge Street.

4. With reference to Article 3 and Schedule 1 thereto (Areas of Highway or Parts of Highway Designated as Parking Places with Permits), amend the foresaid Schedule to include the following length of road:-

Marsh Lane - between points 159 metres and 174 metres from
(north side) Strand Road.
