This means the total number eligible, under the government's current guidance

- In a secondary school, this will be just the key worker and vulnerable children
- In a special school it will be all the children on roll, as they are all classed as vulnerable
- In a primary school, this is the total number of children on roll in reception, year 1 and year 6, plus the key worker and vulnerable children in other year groups.
- Include any other children expected to attend your school from other schools too.

Even if you are operating a rota for pupils, this number should not greatly fluctuate day-to-day
