(BROAGATE FLOOD DEFENCE SCHEME, PRESTON CITY) (TEMPORARY PROHIBITION OF THROUGH TRAFFIC) (TEMPORARY ONE WAY SUSPESNION) (PROHIBITION OF WAITING AND LOADING OR UNLOADING) ORDER 2023

NOTICE IS HEREBY GIVEN that Lancashire County Council have made an Order under **Section 14(1) (b) of the Road Traffic Regulation Act 1984**, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this notice.

- 1. No person shall cause any motor vehicle or cycle to proceed over the following lengths of highway in the city of Preston;
 - i. Riverside, Preston from its junction with South Meadow Lane 120 metres in a southerly direction.
 - ii. South Meadow Lane, Preston from its junction with Riverside for a distance of 14 metres in a westerly direction.
- 2. No person shall cause motor vehicle to wait at any on the following lengths of highway;
 - i. South Meadow Lane, Preston (Northside) from a point 55 metres west of its junction of Riverside for a distance of 140 metres in a westerly direction.
 - ii. South Meadow Lane, Preston (Southside) from a point 14 metres west of its junction of Riverside for a distance of 20 metres in a westerly direction.
- 3. No person shall cause any vehicle to load and unload on the following lengths of highway;
 - i. South Meadow Lane, Preston (Northside) from a point 14 metres west of its junction of Riverside for a distance of 181 metres in a westerly direction.
 - ii. South Meadow Lane, Preston (Southside) from a point 14 metres west of its junction of Riverside for a distance of 20 metres in a westerly direction.
- 4. The prohibitions in articles 1, 2 & 3 shall be operative from 0001 hours Monday 20th March 2023 until 2359 hours on Friday 24th May 2024.
- 5. No person shall cause any motor vehicle or cycle to proceed over the following lengths of highway in the city of Preston;
 - i. Wolseley Road, Preston from its junction with Riverside for a distance of 15 metres in a northerly direction.

- ii. Connaught Road, Preston from its junction with Riverside for a distance of 15 metres in a northerly direction.
- 6. To temporarily suspend the one way prohibitions on the following lengths of highway;
 - i. Wolseley Road, Preston from its junction with Riverside to its junction with Connaught Road.
 - ii. Connaught Road, Preston from its junction with Riverside to its junction with Wolseley Road.
- 7. No person shall cause any motor vehicle to wait at any time or load and unload on the following lengths of highway;
 - Wolseley Road, Preston, both sides including the span of the road closure on Wolseley Road from a point 15 metres north of its junction with Riverside for a distance of 10 metres.
 - ii. Connaught Road, Preston, both sides including the span of the road closure on Connaught Road from a point 15 metres north of its junction with Riverside for a distance of 10 metres
- The prohibitions in articles 3,4 & 5 shall be operative from 0001 hours on Monday 20th March 2023 until 2359 on Monday 23rd October 2023.
- 9. No person shall cause any motor vehicle or cycle to proceed over that length of Riverside, Preston from its junction with South End to a point 120 metres south of its junction with South Meadow Lane.
- 10. The prohibitions in Article 9 shall be operative from 0001 hours on Monday 23rd October 2023 until 2359 hours on Friday 24th May 2024.
- 11. No person shall cause any motor vehicle or cycle to proceed over that length of Riverside, Preston from a point 120 metres south of junction with South Meadow Lane to a point 50 metres west of its junction with Wolseley Road
- 12. The prohibitions in article 11 will be in force from 0001 hours on Monday 20th March 2023 until 2359 hours on Monday 23rd October 2023 or until completion of the works within this period. The prohibitions will only be operative when indicated on site by the presence of the appropriate traffic signs in accordance with The Traffic Signs Regulations and General Directions 2016.
- 13. Nothing in this order shall apply to persons engaged in the carrying out of the works.

14. An alternative route for vehicular traffic affected by the closures will be locally signed.

The temporary prohibitions are necessary to allow major flood defence works to be carried out.
