

NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(CLITHEROE ROAD, GISBURN ROAD, LONGSIGHT ROAD AND
WHALLEY CLITHEROE BYPASS, RIBBLE VALLEY BOROUGH)
(REVOCATION, 40MPH AND DERESTRICTED SPEED LIMIT) ORDER 202*

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Speed Limit Order under Sections 82(2), 83(2) and 84 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Revoke the "Lancashire County Council (A59 Clitheroe Road, and Longsight Road, Ribble Valley) (Revocation, 40mph Speed Limit and Derestriction) Order 2016" insofar as it relates to Item a) of Schedule 1.
2. Introduce a 40mph speed limit on the following lengths of road:
 - a) Whalley Clitheroe Bypass, Wiswell, from a point 585 metres north-east of its roundabout junction with Whalley Clitheroe Bypass, Whalley for a distance of 600 metres in a northerly direction on the northbound;
 - b) Whalley Clitheroe Bypass, Wiswell, from a point 374 metres southwest of its roundabout junction with Whalley Clitheroe Bypass, Pendleton for a distance of 604 metres in a southerly direction on the southbound.
3. Introduce derestricted road status (national speed limit will apply) on the following lengths of road:
 - a) Longsight Road, Copster Green, from a point 187 metres north-east from its junction with Park Gate Row to its junction with Longsight Road, Langho;
 - b) Longsight Road, Langho, from its junction with Longsight Road, Copster Green to its roundabout junction with Whalley Bypass;
 - c) Whalley Bypass, Langho, from its roundabout junction with Longsight Road, Langho to its roundabout junction with Whalley Clitheroe Bypass, Billington;
 - d) Whalley Clitheroe Bypass, Billington, from its roundabout junction with Whalley Bypass, Langho to its junction with Whalley Clitheroe Bypass, Whalley;
 - e) Whalley Clitheroe Bypass, Whalley, from its junction with Whalley Clitheroe Bypass, Billington to its roundabout junction with Whalley Clitheroe Bypass, Wiswell;
 - f) Whalley Clitheroe Bypass, Wiswell, from its roundabout junction with Whalley Clitheroe Bypass, Whalley for a distance of 584 metres in a north easterly direction on the Northbound and for a distance of 880 metres in a north easterly direction on the Southbound;
 - g) Whalley Clitheroe Bypass, Wiswell, from its roundabout junction with Whalley Road for a distance of 344 metres in a south westerly direction on the southbound and for a distance of 631 metres in a south westerly direction on the Northbound;
 - h) Whalley Clitheroe Bypass, Pendleton, from its roundabout junction with Whalley Clitheroe Bypass, Wiswell to its roundabout junction with Whalley Clitheroe Bypass, Worston;
 - i) Whalley Clitheroe Bypass, Worston, from its roundabout junction with Whalley Clitheroe Bypass, Pendleton to its junction with Whalley Clitheroe Bypass, Chatburn;
 - j) Whalley Clitheroe Bypass, Chatburn, from its junction with Whalley Clitheroe Bypass, Worston to its junction with Gisburn Road, Sawley;
 - k) Gisburn Road, Sawley, from its junction with Whalley Clitheroe Bypass, Chatburn to its junction with Gisburn Road, Gisburn;
 - l) Gisburn Road, Gisburn, from its junction with Gisburn Road, Sawley to its junction with Clitheroe Road, Gisburn;
 - m) Clitheroe Road, Gisburn, from its junction with Gisburn Road, Gisburn to a point 359 metres southwest of its junction with the centreline of Mill Lane.
