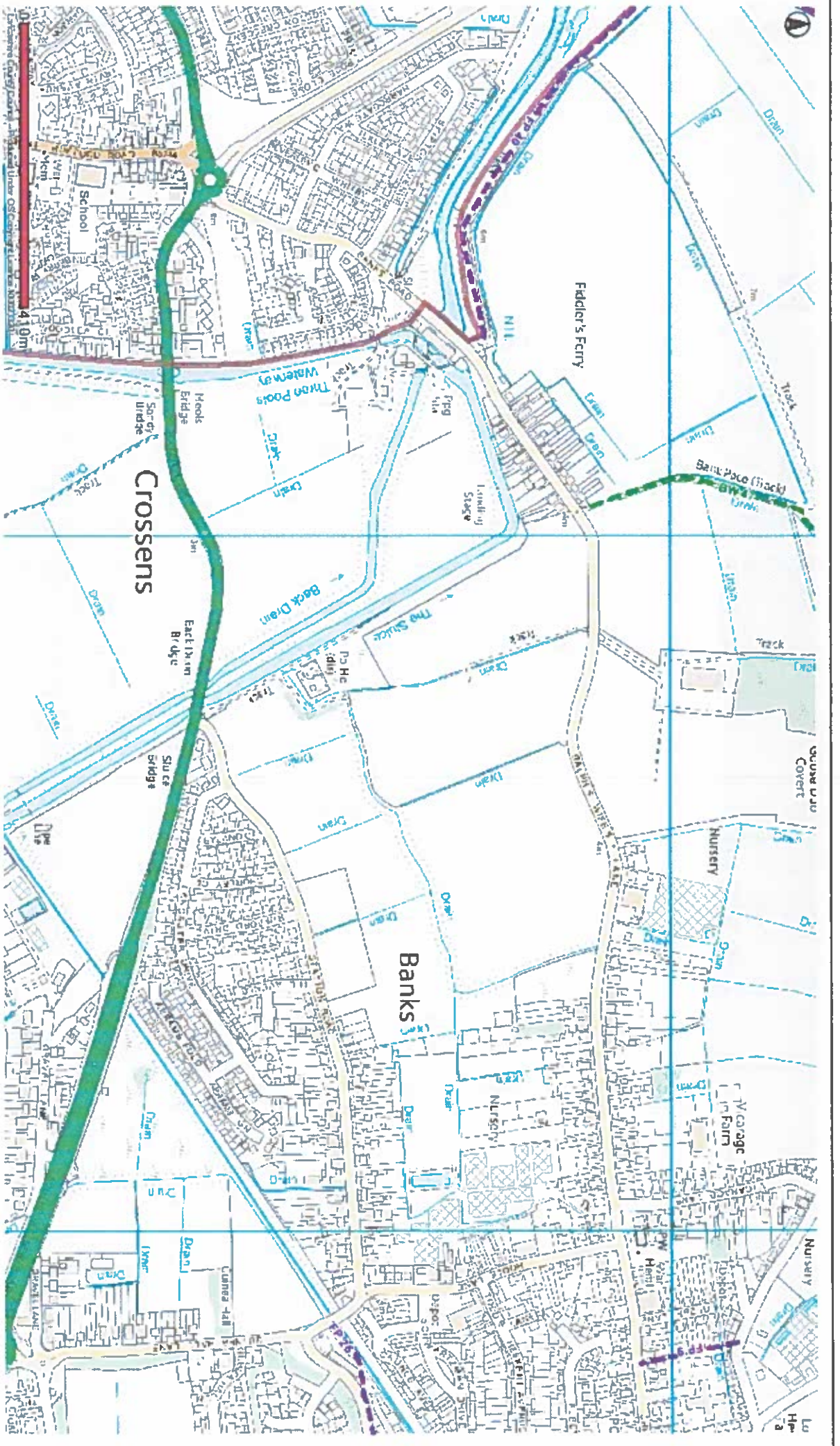

8. What is your favorite food? If you have a favorite, what is it and why do you like it? If you do not have a favorite, what food do you think is the best?

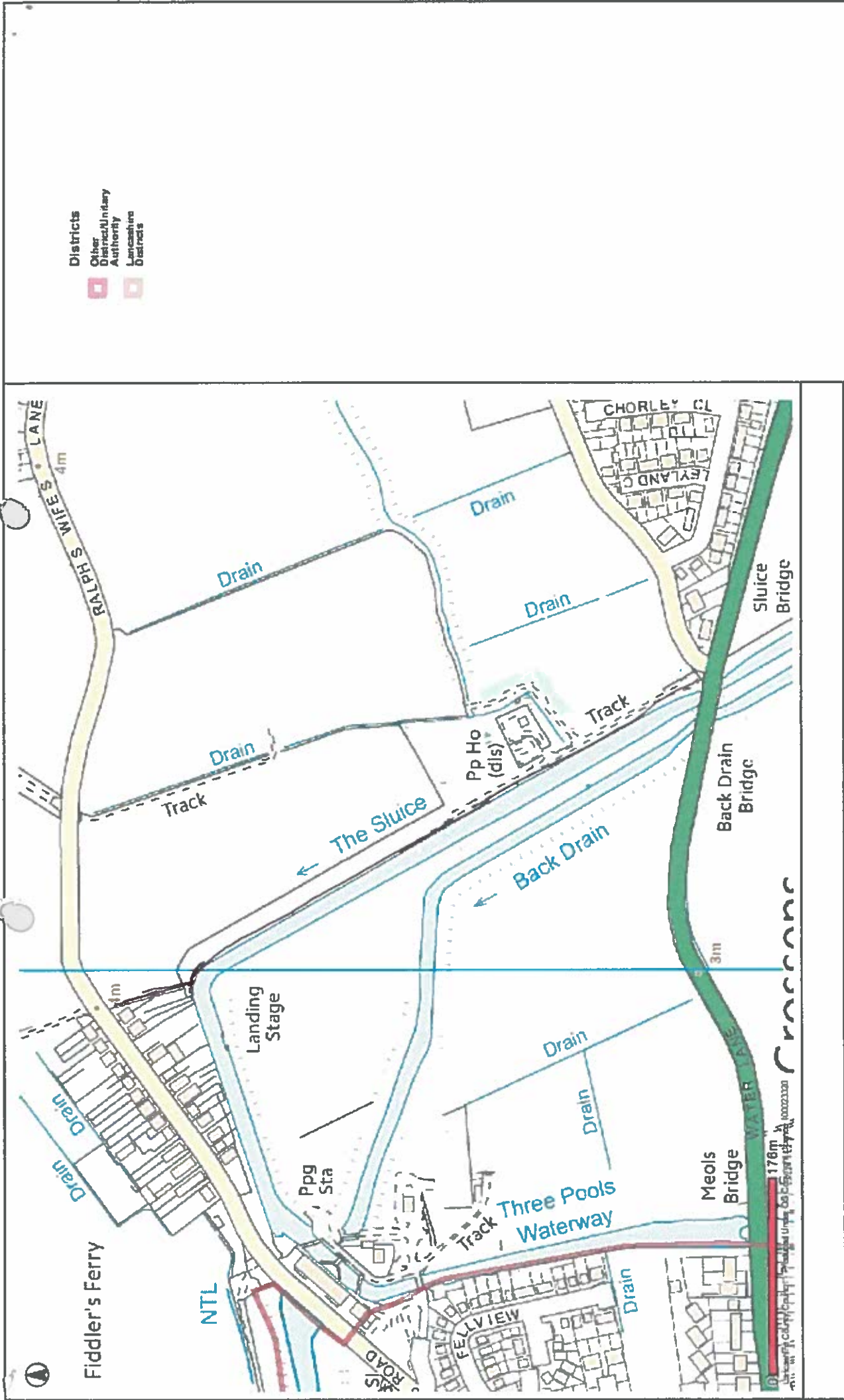
