

NOTICE OF MODIFICATION
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(VARIOUS ROADS, PRESTON CITY AREA) (REVOCATION AND
INTRODUCTION OF PARKING PLACES) ORDER 202*



NOTICE IS HEREBY GIVEN that Lancashire County Council proposed to make the above Traffic Regulation Order under Sections 1, 2, 4, 45 and 46 to the **Road Traffic Regulation Act 1984**, as amended. Following consultation carried out between 20 January 2023 and 17 February 2023, it is now intended to modify the proposed Order as titled above, as set out below.

1. Amend Schedule 3 Permit Holders Only, as follows:

a) Remove Item (30)b) East Cliff Road.

b) Insert the following:

(30)	AV3	East Cliff	b) the north east	From a point 7 metres south east of its junction
		Road, Preston	side	with the centreline of East Cliff for a distance of
				24 metres in a south easterly direction

2. Amend Schedule 19 as follows:

Amend the Schedule title to Pay and Display Parking 8am – 6pm Max Stay 2 Hours No Return within 2 Hours.

Statement of Reasons

The purpose of this modification is to amend the advertised description of the Permit Holders Only Bay on the north east side of the south section of East Cliff Road due to an administrative error in the original proposal.

This modification is also to introduce a 2 hour tariff to the Preston City Centre Pay and Display Parking following objections and feedback in relation to the formal consultation to introduce Sunday charges.

This proposal will facilitate short stay parking provisions for visitors to the city centre and a sufficient time period for people to practice their religion at the number of places of worship around the city centre whilst not impeding on the long stay parking provisions provided by the city centre car parks.
