

ROAD TRAFFIC REGULATION ACT 1984

LANCASHIRE COUNTY COUNCIL

(WHALLEY OLD ROAD, OLD NAB ROAD, BILLINGTON WITH LANGHO, RIBBLE VALLEY BOROUGH)

(REVOCAION, 30MPH SPEED LIMIT AND RESTRICTED ROAD) ORDER 2016

The County Council of Lancashire, in exercise of its powers under Sections 82 and 83 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Revocation

That part of the "Lancashire County Council (Various Roads, Langho, Ribble Valley Borough)(30mph and 40mph Speed Limit) Order 1990" insofar as it relates to item 1 of Schedule 2 to that Order" is hereby revoked as specified in Schedule 1 to this Order.

2. Restricted Road (30mph Speed Limit will apply)

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour which shall become a Restricted Road (as defined in section 82 of the Road Traffic regulation Act 1984): as specified in Schedule 2 to this Order.

3. 30mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour along that length of road as specified in Schedule 3 to this Order.

4. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.


5. Commencement of Order

This Order may be cited as the "Lancashire County Council (Whalley Old Road, Old Nab Road, Billington with Langho, Ribble Valley Borough) (Revocation, 30mph Speed Limit and Restricted Road) Order 2016" and shall come into force on the 27th day of January 2016.

Schedule 1 – Revocation

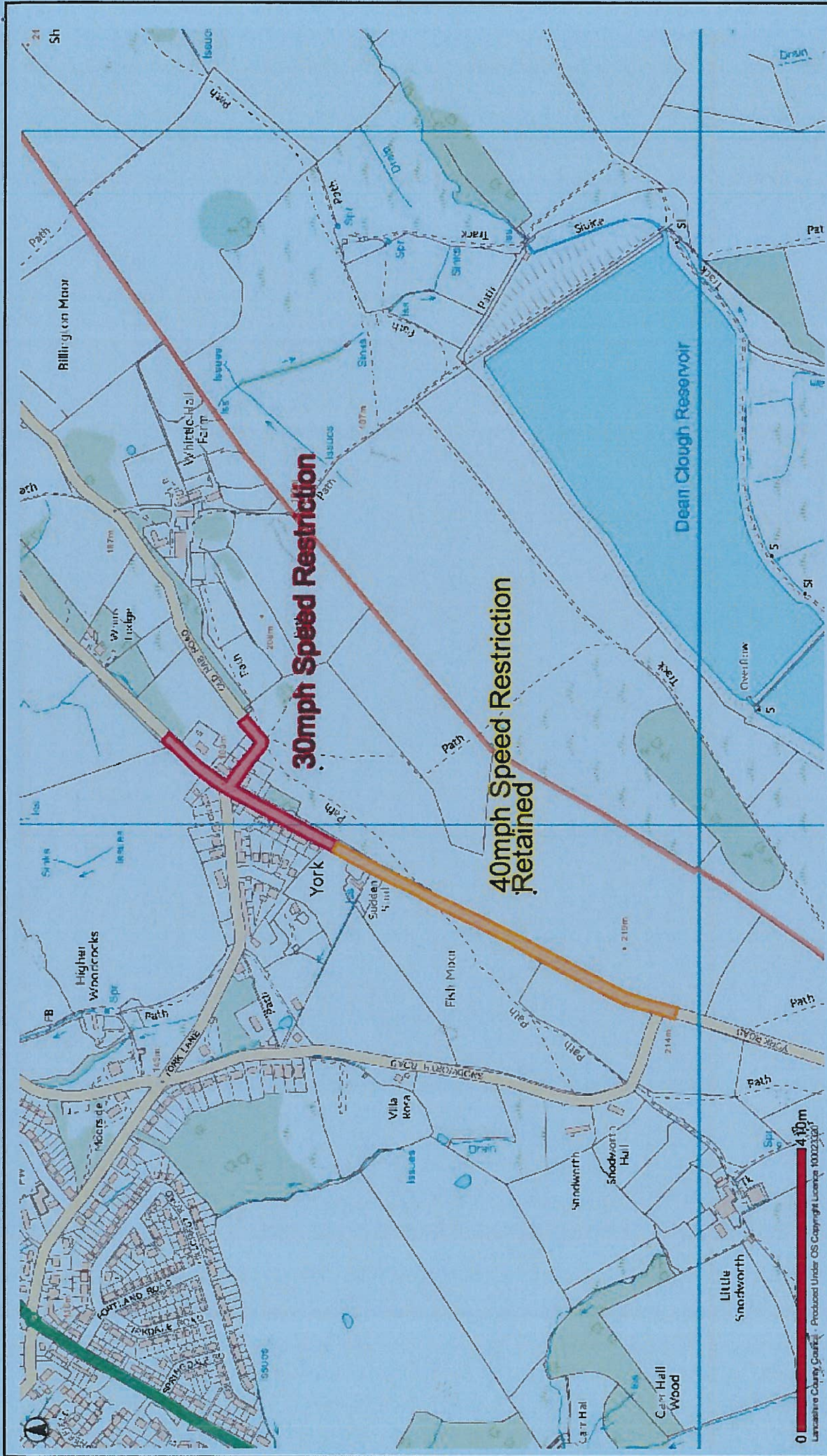
Whalley Old Road and York Road, York between points 20 metres southwest of the junction of York Road with Snodworth Road and 100 metres northeast of the junction of Whalley Old Road with York Lane.

Schedule 2 - Restricted Roads (30mph speed limit will apply)

Whalley Old Road from a point 100m north-east of its junction with the centre line of York Lane to a point 192m south west of its junction with the centre line of York Lane, a distance of 292m.

Schedule 3 - 30mph speed limit

Old Nab Road for a distance of approximately 123m in a south-easterly and north-easterly direction from its junction with the centre line of Whalley Old Road.
