

NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(BORWICK LANE, CHURCH HILL AVENUE, COACH ROAD AND MAIN STREET, WARTON, LANCASTER CITY) (PROHIBITION OF WAITING)
ORDER 202*

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to introduce a prohibition of waiting in the following lengths of road:

- a) Borwick Lane, Warton, both sides, from its junction with the Centreline of Main Street for a distance of 15 metres in a south easterly direction;
- b) Church Hill Avenue, Warton, the north east side, from its junction with the Centreline of Main Street for a distance of 13.5 metres in a northerly direction;
- c) Coach Road, Warton, the north east side, from its junction with the Centreline of Main Street for a distance of 13.5 metres in a north westerly direction;
- d) Coach Road, Warton, the south west side, from its junction with the Centreline of Main Street for a distance of 15.5 metres in a north westerly direction;
- e) Main Street, Warton, the north west side, from its junction with the Centreline of Church Hill Avenue to a point 63.5 metres northeast of its junction with the Centreline of Coach Road;
- f) Main Street, Warton, the south east side, from a point 15 metres southwest of its junction with the Centreline of Borwick Lane for a distance of 56 metres in a north easterly direction;
- g) Main Street, Warton, the south east side, from a point 6 metres northeast of its junction with the projected centreline of Roberts Court for a distance of 17 metres in a south westerly direction;
- h) Main Street, Warton, the south east side, from a point 8 metres north of its junction with the projected centreline of Crag Road for a distance of 15 metres in a southerly direction;
- i) Main Street, Warton, the south east side, from a point 63 metres south of its junction with the projected centreline of Crag Road for a distance of 44 metres in a southerly direction;
- j) Main Street, Warton, the south east side, from a point 164 metres south of its junction with the projected centreline of Crag Road for a distance of 20 metres in a southerly direction;
- k) Main Street, Warton, the south east side, from a point 53 metres east of its junction with the projected Centreline of Church Hill Avenue for a distance of 7.5 metres in an easterly direction.
