Introduction

Welcome to the Lancashire Governor Services Training and Development Programme for 2023/24. As we kick off a new academic year, our rebranded Training Brochure is tailored to align closely with national and regional school governance priorities.

This year, in response to feedback and evolving educational needs. Our emphasis has been on refining the course structures, particularly the length of online courses. Our online courses are concise, informative and are developed to ensure you have the most relevant and up-to-date information to perform your roles. This ensures that even amidst busy schedules, governors can find our training sessions accessible and every minute of participation valuable and productive.

Our approach to flexible learning continues with a combination of face-to-face sessions and online video conferencing courses, allowing participants to engage in a manner that suits their preferences and commitments. Until 31st October, the extended digital course list can be browsed by selecting the 'online' filter on the LPDS website. Eligibility for our courses extends to all governors from schools under the 2023/24 Lancashire Governor Training and Development Service Level Agreement (SLA). Those from nonsubscribing schools are welcome to join on a 'pay-as-you-attend' basis.



How do I book onto a Course?



The Headteacher or school bursar can create you an account. Click login in the top right corner. Enter your username and password. Select your chosen course date/venue, and complete your attendee details, before selecting 'Book Course'. There is no need to add you school information, this is linked to your account.



As a result of your feedback, you now receive an email acceptance or rejection letter direct to your personal email address as well as course correspondence via the Schools' Portal. This email will be sent two to three weeks prior to the course date.

Course confirmation letters will also continue to be sent to the "My Schools Folder" within the Schools' Portal two to three weeks prior to a course. If you have not received a confirmation letter or email by that point, please contact the Customer Support Team on **01257 516100** or **Ipds@lancashire.gov.uk** to check if your application is successful.

If a course is cancelled, you will be given as much notice as possible and offered, where possible, an alternative training session.

Where can I find my Governing Board's Training Record?

It is important to remember that the most definitive record of your governors' training should be kept by the Training and Development Link Governor who should be updated when a governor has attended training.

We are able to provide confirmation of attendance on VENUE courses by emailing **lpds@lancashire.gov.uk**



School Based and Cluster Courses

Many of our courses can be presented by a member of the Tutor Team at your school at a date and time to suit your Governing Board. These Courses can be bespoken to your Governing Board, using your school's own data and reports to focus on key areas or issues that are impacting upon your school.

How do I arrange School Based Training?

It is essential that the Training and Development Link Governor has selected suitable dates and times to ensure maximum attendance before contacting the Governor Training and Development Team. To deliver effective training, ideally a minimum of 8 governors should be present.

The Governor Training and Development Team should be contacted at least eight weeks prior to the preferred date(s) and time(s) to discuss the school's requirements.

What happens next?

Once the date(s) and time(s) have been agreed, the Training and Development Governor and Headteacher will receive written confirmation from the Governor Training and Development Team and will be asked to inform the whole Governing Board of the session. It is essential that the venue has been confirmed, including arrangements for refreshments and/or presenter equipment. Prior to the course, the Tutor will be in contact with the Training and Development Governor (or nominated governor) to discuss the individual requirements of the Governing Board and finalise arrangements for the event.

How do I arrange Cluster Training?

During the booking process for your course, please inform the Training and Development Team if you are planning to invite the governors from other local schools to the session.

Should any of the schools participating in the cluster training not purchase the Governor Training and Development SLA, a 'pay as you use' charge will be made to that school.

Dependant on the nature of the course, a cluster training session may not be appropriate as you may wish to maintain the confidentiality of your school's data for example. In this instance, consideration of the VENUE course programme for governors may be more appropriate.

Additional School based Courses?

For any schools wishing to book additional schoolbased course above their 1 free course, or for non-SLA schools – School Based courses will be priced at £399 per session.







E-Learning for Governors (NGA Learning Link)

Schools that purchase the Lancashire Governor Training and Development Service Level Agreement (SLA) are entitled to free access to the National Governance Association (NGA) e-learning platform. This is called 'Learning Link'. It provides over 50 interactive and engaging modules for your entire board to use. Schools that do not purchase the Lancashire SLA, the individual annual subscription to the NGA for this service is currently £180.

How do you register for learning link?

- 1. Governors should register to access the e-learning at: https://nga.vc-enable.co.uk/Register
- 2. Add your details to the self-registration form in the following order:
 - a. Your first name
 - b. Your last name
 - c. Your email
 - d. Your phone number (optional)
 - e. Your governance role title (optional)
 - f. Your school or academy use the search box and make sure to select the right one using the postcode*
- 3. Click the green register button to submit your application for approval.
- 4. Approval is not immediate, and you must wait for email confirmation of approval. It can take time to receive this email particularly if your application is submitted over a weekend or in the evening.
- 5. Your confirmation email will be sent to you. Once you receive your email confirmation, which includes your login details you can login to Learning Link and start to use it whenever you want to.



Your role on governing body panels


The course will:

- outline the common principles and procedures to be followed;
- explain the roles of the Chair of the panel, Clerk, HR and other Specialist Advisers;
- practice the skills of listening to presentations and asking the right questions;
- outline the processes for making decisions, recording the rationale and delivering outcomes; and
- practice decision making skills using case studies.

Governors are asked to sit on a wide range of occasional committees or panels with a decision-making role including Pupil Discipline, Staff Discipline, Staff Grievance, Disciplinary Appeals, Parental Complaints, Pay Appeals, etc.

All of these have common features and approaches but, because these committees tend to meet infrequently, governors may have little knowledge or experience of having to make difficult decisions in sometimes challenging cases.

Using case studies, exercises and discussion, this workshop will develop governors' knowledge and skills around the procedures used and the processes for reaching fair, reasonable and defensible decisions.


