

NOTICE OF MODIFICATION
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(BERRY LANE, DERBY ROAD, KESTOR LANE, MARKET PLACE AND
PRESTON ROAD, LONGRIDGE, RIBBLE VALLEY BOROUGH)
(REVOCAION, PROHIBITION AND RESTRICTION OF WAITING AND
LIMITED WAITING) ORDER 202*



NOTICE IS HEREBY GIVEN that Lancashire County Council proposed to make the above Traffic Regulation Order under Sections 1, 2 and 4 to the **Road Traffic Regulation Act 1984**, as amended. Following initial consultation carried out between 24 May 2023 and 21 June 2023, and consultation carried out on a modification between 19 July 2023 and 16 August 2023 it is now intended to further modify the proposed Order as titled above, as set out below.

1. Remove the following from Schedule 2:
 - b) Berry Lane, Longridge, the north east side, from a point 84 metres southeast of its junction with the Centreline of Inglewhite Road for a distance of 37 metres in a south easterly direction.
 - c) Berry Lane, Longridge, the north east side, from a point 3.5 metres southeast of its junction with the Centreline of Mersey Street for a distance of 27 metres in a south easterly direction.
 - f) Derby Road, Longridge, the east side, from a point 24.5 metres north of its junction with the projected Centreline of Alexandra Road for a distance of 37 metres in a northerly direction.
 - i) Derby Road, Longridge, the west side, from a point 8 metres south of its junction with the Centreline of Blackpool Road for a distance of 27 metres in a southerly direction.
 - j) Derby Road, Longridge, the west side, from a point 22 metres south of its junction with the Centreline of St Wilfrid's Terrace for a distance of 37 metres in a southerly direction.
 - k) Kestor Lane, Longridge, the north side, from a point 14 metres west of its junction with the projected Centreline of Hillcrest Drive for a distance of 37 metres in an easterly direction.
 - l) Kestor Lane, Longridge, the north side, from a point 28.5 metres east of its junction with the projected Centreline of Beech Drive for a distance of 37 metres in an easterly direction.
 - o) Preston Road, Longridge, the east side, from a point 5 metres north of its junction with the Centreline of the southern arm of Southern Close for a distance of 33.5 metres in a northerly direction.
 - p) Preston Road, Longridge, the east side, from a point 1.6 metres south of its junction with the projected Centreline of Queen Street for a distance of 31.5 metres in a southerly direction.
 - q) Preston Road, Longridge, the west side, from a point 10 metres south of its junction with the Centreline of Monks Drive for a distance of 28 metres in a southerly direction.
2. Remove Schedule 3 Restriction of Waiting Monday to Friday 8am – 6pm. Preston Road, Longridge, the east side, from a point 38.5 metres north of its junction with the projected Centreline of Hacking Drive for a distance of 76.7 metres in a northerly direction.
3. Remove the following from Schedule 5:
 - a) Berry Lane, Longridge, the north east side, from a point 121 metres southeast of its junction with the Centreline of Inglewhite Road to its junction with Mersey Street.
 - b) Berry Lane, Longridge, the north east side, from a point 30.5 metres southeast of its junction with the Centreline of Mersey Street to a point 23.5 metres northwest of its junction with the Centreline of Market Place.
 - c) Berry Lane, Longridge, the northeast side, from a point 10.5 metres southeast of its junction with the centreline of Inglewhite Road for a distance of 73.5 metres in a south easterly direction.
3. Insert the following into Schedule 5:

Berry Lane, Longridge, the north east side, from a point 10.5 metres south east of its junction with the centreline of Inglewhite Road to a point 23.5 metres north west of its junction with the centreline of Market Place.
4. Remove the following from Schedule 6:
 - a) Berry Lane, Longridge, the south west side, from a point 4.3 metres northwest of its junction with the Centreline of Brewery Street for a distance of 13.3 metres in a north easterly direction.
5. Insert the following into Schedule 6:
 - a) Berry Lane, Longridge, the south west side, from a point 4.3 metres northwest of its junction with the Centreline of Brewery Street for a distance of 13.3 metres in a north westerly direction.

Statement of Reasons

The purpose of this modification is to remove the NWAAT restrictions in the areas of the new bus stop clearways because having assessed the restrictions against our most recent proposals, they are no longer deemed necessary.

The No Waiting restriction from Monday to Friday, 8am to 6pm situated on Preston Road from a point 38.5 metres north of the junction with Hacking Drive for a distance of 76.7 metres is being removed because having assessed the restriction against our most recent proposals, it is no longer deemed necessary.
