### **ASS160 – NEW - KS1 Supporting Teacher Judgements through Effective Moderation**

From the academic year 2023/2024 schools are no longer required to submit data for children at the end of Key Stage 1 however moderation continues to be identified as best practice and the opportunity to engage in professional discussions with colleagues is invaluable. This new half day course allows participants the opportunity to explore standardisation materials, which will support a shared understanding of a standard and then participate in professional discussions about children's work. These discussions will then focus on identifying the next steps that are needed to support the child moving on in their learning.

### **ASS132 - Access Arrangements for the End of Key Stage 2: Statutory Assessments in 2024**

This half day course will look at access arrangements in key stage 2 for 2024. It will consider all the guidelines from the Standards and Testing Agency (STA) on the use of access arrangements including rest breaks, transcripts, readers, and amanuenses. Discussion and guidance will be given around good practice utilised in the organisation of Access Arrangements. Further advice will outline the correct procedures to use when applying for access arrangements such as additional time.

### **ASS184 - Year 6: Understanding the Assessment Procedures for 2023/2024**

The course will provide guidance on the management and administration of the end of Key Stage 2 assessment arrangements for 2023/2024. It will consider the requirements regarding the use of Statutory Assessment tests; the formulation of teacher assessment judgements against national expectations; potential use of assessment data and requirements of reporting to parents. This course will help you plan your time effectively and help you prepare for the end of year arrangements, including moderation requirements.

**ASS177 - EYFS Assessment Update to Support End of Year Judgements**

This half day training session will be based upon the Early Learning Goals and will give delegates the opportunity to look at three areas in detail. There will also be key updates provided in relation to EYFS and opportunities given for colleagues to discuss approaches that they have been taking in this year. During the session there will be the opportunity for participants to take part in agreement trialling as well as moderation of their own evidence. We ask that each participant brings along with them evidence for a child in their class for the areas Managing Self; People, Culture and Communities and Creating with materials.

**ASS125 - Applying Rosenshine's Principles of Instruction in School part 3 - Sequencing and Modelling**

This half day course will give delegates the opportunity to deepen their understanding of Rosenshine's Principles of Instruction and consider how to implement these in school. The course will give delegates an overview of Rosenshine's Principles and then focus on methods to sequence concepts to support learning in small steps. We will also examine strategies for modelling and scaffolding; how to implement these effectively and ensure that students do not become over reliant on the scaffolds used.
