

**NOTICE OF PROPOSAL**  
**ROAD TRAFFIC REGULATION ACT 1984**  
**LANCASHIRE COUNTY COUNCIL**  
**(BRIDGE STREET, CHURCH STREET, HIGH STREET AND MARKET PLACE, GARSTANG, WYRE BOROUGH) (REVOCATION, PROHIBITION AND RESTRICTION OF WAITING AND LIMITED WAITING PARKING PLACE) ORDER 202\***

**NOTICE IS HEREBY GIVEN** that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Revoke the "Lancashire County Council (Various Roads, Garstang, Wyre Borough) (Part Revocation, Prohibition of Waiting, Restriction of Waiting and Restriction of Loading/Unloading) Order 2011" insofar as it relates to:
  - a) Items e), f) and g) of Schedule 2;
  - b) Items h) and f) of Schedule 3;
  - c) Item b) of Schedule 6.
2. Introduce a prohibition of waiting in the following lengths of road:
  - a) Bridge Street, Garstang, the north east side, from a point 40.5 metres south east of its junction with the centreline of Coach House Mews to a point 28 metres south east of its junction with the centreline of Park Hill Road;
  - b) Bridge Street, Garstang, the north east side, from a point 10 metres north west of its junction with the centreline of Coach House Mews for a distance of 31 metres in a south easterly direction;
  - c) High Street, Garstang, the west side, from its junction with the centreline of Croston Road for a distance of 60.5 metres in a southerly direction.
3. Introduce a restriction of waiting Monday to Saturday between 8am and 6pm in the following lengths of road:
  - a) Church Street, Garstang, the north west side, from its junction with the centreline of Market Place for a distance of 13 metres in a south westerly direction;
  - b) High Street, Garstang, the west side, from a point 60.5 metres south of its junction with the centreline of Croston Road to its junction with the centreline of Market Place;
  - c) Market Place, Garstang, the north west side, from its junction with the centreline of High Street to its junction with the centreline of Church Street.
4. Introduce a limited waiting parking place for 30 minutes with no return within 30 minutes Monday to Saturday 8am to 6pm in Bridge Street, Garstang, the north east side, from a point 23 metres south east of its junction with the centreline of Coach House Mews for a distance of 17.5 metres in a south easterly direction.
