## NOTICE OF PROPOSAL ROAD TRAFFIC REGULATION ACT 1984 LANCASHIRE COUNTY COUNCIL (DENT ROW AND HALSTEAD STREET, BURNLEY, BURNLEY BOROUGH) (REVOCATION, PROHIBITION AND RESTRICTION OF WAITING AND TAXI STAND) ORDER 202\*

**NOTICE IS HEREBY GIVEN** that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984,** as amended, the effect of which will be to:

- 1. Revoke the "Lancashire County Council (Burnley Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Order 2009" insofar as it relates to the following:
  - a) Items (102) and (132) of Schedule 10.01;
  - b) Item (37) of Schedule 11.008.
- 2. Introduce a prohibition of waiting in the following lengths of road:
  - a) Dent Row, Burnley, the south east side, the entire length;
    - b) Dent Row, Burnley, the north west side, from its junction with the Centreline of Trafalgar Street for a distance of 47 metres in a south westerly direction;
    - c) Dent Row, the north west side, from a point 57 metres south west of its junction with the Centreline of Trafalgar Street to its junction with the Centreline of Halstead Street;
    - d) Halstead Street, Burnley, the north east side for its entire length;
    - e) Halstead Street, Burnley, the south west, from its junction with side the centreline of Manchester Road for a distance of 29 metres in a north westerly direction;
    - f) Halstead Street, Burnley, the south west side, from a point 67 metres north west of its junction with the centreline of Manchester Road for a distance of 11 metre in a north westerly direction.
- 3. Introduce a restriction of waiting between 8am and 6:30pm in Halstead Street, Burnley, the south west side, from a point 33 metres north west of its junction with the Centreline of Manchester Road for a distance of 34 metres in a north westerly direction.
- 4. Introduce a taxi stand in Dent Row, Burnley, the north west side, from a point 47 metres south west of its junction with the Centreline of Trafalgar Street for a distance of 10 metres in a south westerly direction.
