NOTICE IS HEREBY GIVEN that Lancashire County Council has made an Order under **Section 14(1) (b) of the Road Traffic Regulation Act 1984**, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this notice.

- 1. No person shall cause any vehicle to wait in the following lengths of Rectory Road, Grosvenor Street, Holme Road, Ashley Street and Cavour Street as per schedule 1 attached.
- 2. Nothing in this order shall apply to persons engaged in the carrying out of the works.
- 3. The prohibition will be operative daily from 0700 hours on Monday 19th February 2024 until 2359 hours on Tuesday 19th August 2025 or until it is deemed the prohibition is no longer required.

The temporary prohibition is necessary to ensure that vehicles are not left in locations that can cause a danger to other road users including pedestrians around Burnley College area.
