

NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(ST MARTINS ROAD AND ST OSWALD STREET, LANCASTER,
LANCASTER CITY) (REVOCATION, PROHIBITION OF WAITING AND
TAXI STAND) ORDER 202*

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Revoke the "Lancashire County Council (Lancaster Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009" insofar as it relates to:
 - a) Item (13) of Schedule 3.06;
 - b) Item (449)b(i) of Schedule 10.01;
 - c) Item (7) of Schedule 10.12;
 - d) Item (7) of Schedule 13.05.
2. Introduce a prohibition of waiting in the following lengths of road:
 - a) St Martins Road, Lancaster the east side, from its junction with the Centreline of Clarence Street to a point 22 metres north of its junction with the Centreline of Vincent Street.;
 - b) St Martins Road, Lancaster, the east side, from a point 5 metres south of its junction with the projected Centreline of Rear 6-42 Vincent Street for a distance of 7.5 metres in a southerly direction.;
 - c) St Oswald Street, Lancaster the south east and south side, from its junction with the Centreline of Bowerham Road for a distance of 34 metres in a north easterly, then easterly direction.
3. Introduce a taxi stand in St Martins Road, Lancaster, the east side, from a point 4 metres north of its junction with the projected Centreline of Wesham Street for a distance of 5.5 metres in a southerly direction..
