

NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(COCKERSAND DRIVE, HALA ROAD AND LENTWORTH DRIVE,
LANCASTER, LANCASTER CITY) (REVOCATION, PROHIBITION OF
WAITING AND LIMITED WAITING) ORDER 202*

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Revoke the "Lancashire County Council (Lancaster Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009" insofar as it relates to:
 - a) Items (215)a(i), (215)a(ii), (215)b, (215)c and (265)b of Schedule 10.01;
 - b) Items (3) and (6) of Schedule 12.084.
2. Introduce a prohibition of waiting in the following lengths of road:
 - a) Cockersand Drive, Lancaster, both sides, from its junction with the centreline of Hala Road for a distance of 10 metres in a southerly direction;
 - b) Hala Road, Lancaster, the north side, from its junction with the centreline of Scotforth Road (A6), for a distance of 72 metres in an easterly direction;
 - c) Hala Road, Lancaster, the north side, from a point 93 metres east of its junction with the centreline of Scotforth Road (A6), to its junction with the centreline of Claughton Drive;
 - d) Hala Road, Lancaster, the south side, from a point 121 metres west of its junction with the centreline of Cockersand Drive to its junction with the centreline of Scotforth Road (A6);
 - e) Halal Road, Lancaster, the south side, from its junction with the centreline of Claughton Drive to a point 33 metres west of its junction with the centreline of Cockersand Drive;
 - f) Lentworth Drive, Lancaster, the west side, from a point 54 metres north of its junction with the centreline of Hala Road for a distance of 98 metres in a north westerly direction.
3. Introduce a limited waiting parking place for 1 hour with no return within 2 hours Monday to Saturday 8am – 6pm in Lentworth Drive, Lancaster, the west side, from a point 30 metres north of its junction with the centreline of Hala Road for a distance of 24 metres in a northerly direction.
