

**NOTICE OF MODIFICATION**  
**ROAD TRAFFIC REGULATION ACT 1984**  
**LANCASHIRE COUNTY COUNCIL**  
**(BOWERHAM ROAD, MALVERN AVENUE AND PARKFIELD DRIVE,**  
**LANCASTER, LANCASTER CITY) (REVOCATION AND PROHIBITION OF**  
**WAITING) ORDER 202\***

**NOTICE IS HEREBY GIVEN** that Lancashire County Council proposed to make the above Traffic Regulation Order under Sections 1, 2 and 4 to the **Road Traffic Regulation Act 1984**, as amended. Following consultation carried out between 04 May 2023 and 01 June 2023, it is now intended to modify the proposed Order as titled above, as set out below.

1. Remove Item (76)e)(iv) from Schedule 1 – Revocation.
2. Revoke the "Lancashire County Council (Lancaster Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009" insofar as it relates to the following:
  - a) Items (76)b)(ii), and (76)d) of Schedule 10.01.
  - b) Item (1) of Schedule 12.082.
3. Remove the following from Schedule 2 – Prohibition of Waiting:
  - a) Bowerham Road, Lancaster, the north east side, from its junction with the Centreline of The Grove to its junction with the Centreline of Back Bowerham Road East in a south easterly direction.
  - b) Bowerham Road, Lancaster, the south west side, from a point 13.5 metres southeast of its junction with the Centreline of Somerset Avenue to a point 25 metres northwest of its junction with the Centreline of Parkfield Drive.
4. Introduce a prohibition of waiting in the following lengths of road:
  - a) Adelphi Street, Lancaster, both sides, from its junction with the centreline of Bowerham Road for a distance of 11 metres in a north easterly direction;
  - b) Bowerham Road, Lancaster, the north side, from its junction with the centreline of Meadowside to its junction with the centreline of St Oswald Street;
  - c) Bowerham Road, Lancaster, the north east side, from its junction with the centreline of St Oswald Street for a distance of 39.5 metres in a south easterly direction;
  - d) Bowerham Road, Lancaster, the north east side, from a point 110.5 metres south east of its junction with the centreline of St Oswald Street for a distance of 57 metres in a south easterly direction;
  - e) Bowerham Road, Lancaster, the north east side, from a point 211.5 metres south east of its junction with the centreline of St Oswald Street for a distance of 44 metres in a south easterly direction;
  - f) Bowerham Road, Lancaster, the south side, from a point 266 metres north west of its junction with the centreline of Parkfield to its roundabout junction with Greaves Road (A6);
  - g) Bowerham Road, Lancaster, the south west side, from a point 25 metres north west of its junction with the centreline of Parkfield Drive to a point 7 metres south east of its junction with the centreline of Malvern Avenue.
5. Introduce a limited waiting parking place for 1 hour with no return within 2 hours Monday to Friday 8am – 6pm in the following lengths of road:
  - a) Bowerham Road, Lancaster, the south west side, from a point 114.5 metres north west of its junction with the centreline of Parkfield Drive for a distance of 25.5 metres in a north westerly direction;
  - b) Bowerham Road, Lancaster, the south west side, from a point 159.5 metres north west of its junction with the centreline of Parkfield Drive for a distance of 106.5 metres in a north westerly direction.
