Upgrading of Wrightington Footpath 21 to Bridleway

There has been a series of inconsistencies and contradictions by the officers of Lancashire County Council.

1) The conclusion in the council meeting of the 13th May 2015 states:

in order to satisfy the criteria of Section 31 there must be sufficient evidence of use of the claimed route by the public, as of right and without interruption over the 20 year period immediately prior to its status being brought into question

There has been no right of way granted for horses to use the footpath at any time during the last 20 years. It has been proven that as landowners we actively stopped horse riders from using our footpath due to dangerous incidents. We even put a barrier up for several months to enable pedestrians to use the path without the danger of horses. The footpath exits directly onto Moss Lane and we were concerned for the safety of the footpath users.

2) Mr Goode, from the council, claimed in the meeting that the footpath has been used by horses for 20 years uninterrupted. This is not true as the council put up signs themselves in 2011 which are still in situ at both ends of the footpath. The telephone number on the signs are Lancashire County Hall.

This evidence proves that the footpath has been illegally used by occasional horse riders and against our wishes and has not been used without interruption over a 20-year period.

- 3) In the regulatory meeting 13<sup>th</sup> May 2015 it was stated that the landowners were unknown to the council. However, Wayne Selway (LCC Property Land Agent) from the council had approached the landowners in 2012 and 2013 and we all refused to allow the "upgrade" to bridle path due to the health and safety issues
- 4) There was non-disclosure from the chair of Wrightington Parish Council of any interest in the process although she owns the local horse riding stable. Councillor Burton actively sought local, and not local people, to sign letters of support. She personally visited her horse loving friends and sought their backing. Nowhere did she disclose any personal interest in the matter at Wrightington Parish Council meetings when starting the crusade. Unfortunately, Lancashire Council paralegal team did not see this as a conflict of interest and deemed that Clir Burton had not taken advantage of her position as Chair of the Parish Council to benefit her own riding business. A point which we refute as one of Clir Burton's instructors, when questioned why she was riding illegally up our footpath, replied she had been instructed to take her novice horse riders on that route by Clir Burton.

I feel that the entire process has been flawed, inconsistent, contradictory and carried out at the least, immorally and at the worst, illegally, with the full facts not being considered in a balanced manner.

I am writing to object to the Definitive Map Modification order 2016 for the above footpath

In the Council's regulatory meeting of 15<sup>th</sup> May 2015 the decision was taken to make the order that Wrightington footpath 21 be upgraded to bridleway under s. 31 Highways Act

Under s.31 of the Highways act there must be sufficient evidence of use of the claimed route by the public, as of right and without interruption, over the twenty-year period immediately prior to its status being brought into question, in order to raise a presumption of dedication.

#### The criteria of 'no interruption' cannot not be satisfied

- As landowners we have challenged whenever there has been an attempted inappropriate use by equestrians within the relevant 20 year period 1994-2014 and there is documentary evidence of this
- 2) LCC have themselves erected 'footpath no horse riding' signs within this period (Nov 2010) due to a complaint by a member of the public that an incident of attempted equestrian use had caused a public nuisance. The signs are still in place to this day.

#### No intention to dedicate

As landowners we were approached in 2013 by LCC Land agent Wayne Selway to ask if we would consider the upgrade of FP21 to bridleway. There is documented email correspondence from that time, stating we did not give our permission for an upgrade, which clearly shows that there was no intention on the part of us as landowners to dedicate the route as a bridleway.

#### Inconsistencies and contradictions at Regulatory meeting

- We are also objecting on the basis that at the regulatory meeting in May 2015 the decision to make the order of upgrading the footpath was incorrect as the council were in possession of all the above evidence along with the evidence from OS maps dating back to the 1700s showing the right of way as a footpath. Their own conclusion in the report from that meeting states 'the map and other documentary evidence is in itself considered to be insufficient to conclude the route was a historical public bridleway and it is therefore suggested to committee that inferred dedication cannot on balance be satisfied'
- There are contradictions and inconsistencies in the council's own report from this meeting and there was no evidence whatsoever to support the outcome of the decision to make the order.

#### Collusion

 We feel there has been collusion between various parties involved who have not declared their interests as Councillor Oakes who was chair of the Regulatory committee is also chair of the Public Rights of Way and Access forum and is known to the owner of the local riding school, cllr Judith Burton who is the BHS representative for the PROW forum

#### User evidence unreliable

- We would also point out that the report from the regulatory meeting states that the investigation that the route should be recorded as a bridleway followed submission by Wrightington Parish Council of user evidence. The chair of Wrightington Parish Council is also the owner of the local riding school and is pressing for the upgrade to her own advantage, therefore the input from the parish council is not reliable. The Chair did not declare her interest when the subject of FP21 was discussed at parish council meetings.
- The chair also did not adhere to the parish council code of conduct 6.1

'You must not use or attempt to use your position as a member improperly to confer on or secure for yourself or any other person, an advantage or disadvantage.'

The user evidence forms are unreliable as they were not distributed to a diverse selection of the residents, only to people known to the owner of the local riding school who inferred that the council were planning on closing the footpath if people did not send the forms in.

In addition to these representations and objections, we also once again raise the issue of safety to pedestrians who are the authorised users of the footpath and to whom equestrian use would cause a public nuisance. The path is less than 2 metres for most of its length and is not suitable for both pedestrians and equestrians.

The measurements of the path supplied by the council are inaccurate as the fence on the side bordering Chapel field is not in the original position and will be moved back to its original position making the width 6ft.

I lived in Wrightington for over 20 years and used the footpath in question many times. In all those times, I never encountered an equestrian user. If there had been a horse and rider on the path I would have been concerned for my safety as a pedestrian. The path is not wide enough for a horse to pass a walker and there is also a blind bend which would be very dangerous for a pedestrian.

I have owned horses myself while living in Wrightington and it has always been local knowledge that it is a footpath and not a bridleway. There have been council erected signs for many years at both ends of the footpath stating that it is a footpath and no equestrian use.

If there is a need for more bridleways in the area, they should be safe for all users, pedestrians and equestrians and this footpath is not.

#### Dear Sir,

We are writing to object to the proposal to change Public Footpath 21 in Wrightington from SD5358 1094 to a public bridleway. The footpath is not suitable for upgrading in this way for the following reasons:

- 1. High speed travel riders do not always ride responsibly
  - a. riders have ridden at high speed along the footpath. This compromises safety, and emphasizes my other concerns detailed below. These activities were not authorized by the owners of the land over which the footpath passes
  - b. The abrupt transition from a grass/earth surface to tarmac at point F is has caused at least one horse to fall. The change in surface is not clearly visible as riders approach the change

#### 2. Restricted width -

a. The effective, usable width of the footpath is much less than the widths quoted in the Notification Order, for example between D and F. The effective width is often around 1m, with nettles, thistles and brambles occupying the remaining space. This width is not sufficient to allow a pedestrian to pass a horse safely, or to avoid a horse travelling at speed, especially where visibility is restricted. It would be impossible for a child in a buggy/pram or wheelchair to pass a horse using the footpath.






Narrow effective width – tape indicates 39-40 inches






Restricted space at side of footpath

- b. There is nowhere for a rider to avoid people or pets on the footpath. If the horse were to be panicked by a dog, and adult or a child, then this would lead to an uncontrolled, unsafe situation for all concerned. Children would be especially vulnerable.
- 3. Visibility there are several places where visibility of hazards is poor
  - a. Between points F and G there are driveways to houses. Riders will not be able to see vehicles or people leaving these houses, and vehicles or people exiting these houses will not have a clear view of riders. This poor visibility increases the risk of a collision, especially if riders travel at unsafe speeds or are not concentrating on these hazards.

b. The footpath has a number of bends in it, for example at point D. A runner, or dog emerging at these points of restricted visibility could easily startle a horse, causing an unsafe situation, made worse by the restricted usable width of the footpath, as described for restricted width:












Poor traffic visibility on exit to Moss Lane – note white van in last picture

## 4. Restricted Headroom -

a. parts of the footpath have restricted headroom due to the overgrowth of trees, especially between points C and D. There is not sufficient headroom for safe passage on horseback:

# 5. Surface damage -

a. the footpath surface cannot support horse traffic, as it is muddy in places, such as between points E and F, or is subject to standing water around point C. Horse traffic will render the footpath unusable to the majority of other users. Travel by wheel chair will become impossible.

b. Horse traffic will damage the unmade lane between points F and G, causing access problems and increased maintenance costs for residents:

#### 6. Potential conflict of interest -

a. We note that Parish Councillor Mrs J Burton's address is that of Roofcroft's Riding Stables at Courage Low Lane, Wrightington, WN6 9PJ. Has she declared this interest, and has she been involved in any discussions or decisions made about the change in status?

Because of these factors we do not believe that the change in status should be made. Any resulting bridleway would be unsafe for horse riders and pedestrians, limit access in favour of horse riders, and degrade the existing footpath to an unacceptable degree. We would suggest that the Planning Inspectorate visit the site to fully understand the nature of these objections.

# Ref - LSG4/CB/PROW/5.5315 -Footpath 21 - Moss Lane to Mossy Lea Road Wrightington.

I wish to write and object regarding the proposal to designate Footpath 21 between Moss Lane and Mossy Lea Road Wrightington to a Bridleway.

As a regular user of this footpath for over 50 years I have used this path as a shortcut between my home and the school and church and also regularly for walking dogs. This footpath is extremely narrow in places, designating it as bridleway could be extremely intimidating when out walking but especially so when walking with dogs if you were to come face to face with riders and horses particularly so around a blind corner. Potentially this could also lead to unnecessary conflict and danger to both walkers, riders and animals. In winter the path can become extremely wet and muddy underfoot .its use by horses can only make this situation worse and lead to further deterioration of the footpath and its use by walkers.

I would also wish to point out that the exit of the path onto Moss Lane is very narrow and goes straight out onto the road this poses an undoubted danger to horses and riders entering onto Moss Lane and vehicles driving along Moss Lane being quite close to a blind bend.

I understand It is only in the last few years that the path has been used 'illegally' by riders and horses' despite notices being put up that by the council itself prohibiting horses from using the path. If the path were to be designated a bridleway myself and my family would definitely be discouraged from using the path at the risk of encountering horses particularly in the narrow and blind sections of the path

Again if the proposal were to be passed by the Council I would not feel at ease using the path in future if only to avoid any potential conflict and the risk implications of encountering horses especially when walking dogs. On grounds of safety and its unsuitability as a bridleway the proposal should be rejected by the Council in the interests of walkers, joggers, rider's animals and visitor's to the area.

I would add I have no objection at all to riders and horses using the existing bridleways in the area and enjoy seeing them in general in the village and local area. I just do not consider this particular path is suitable to be designated as a bridleway for the reasons I have outlined above.

I would also wish to pint out I have personally never come across horses and riders using this path in all the time I have lived in Moss Lane over 60 years.

Dear Mr-Young,

I would like to make you aware of my strong objection to Wrightington Footpath 21 being upgraded to a bridleway on the following points:-

- A) I have documentation showing that my grandfather, Thomas Calderbank, owned only a six foot wide footpath between the adjoining fields, incorporating a blind corner, much too dangerous for walkers encountering horses.
- B) Identified, occasional horse riders have been challenged over the years with their illegal use of the footpath and the council advised at the time.
- C) User evidence forms were distributed selectively by the chair of Wrightington Parish Council who is also owner of the local riding school and also the County Access and Bridleways Officer for the British Horse Society. I have since spoken to some of the signatories who signed under duress as they were under the impression that the path could be potentially closed to all users if they didn't sign.

I would like to request an oral hearing as I believe this bridleway application fails the basic evidence test.

We wish to write and object to the proposal to designate Footpath 21 between Moss Lane and Mossy Lea Road Wrightington to a Bridleway.

As regular users of this footpath for many years we have used this path as a shortcut between our house on Moss Lane and the school to collect our children and the church and also regularly for walking dogs. The footpath is very narrow in places with some blind bends it could be very frightening and intimidating especially when walking dogs if you were to come across a group of riders and horses. This could lead to danger to both walkers, riders and animals. Also in winter the path does become very muddy and wet, its use by horses can only make this worse and lead to further worsening of the state of footpath for use by walkers.

We would also wish to point out that the exit of the path onto Moss Lane is very narrow and straight onto the road this is a danger to both horses, riders and traffic using Moss Lane being very close to a blind bend from the main road.

It is only in the last few years that the path has been used 'by horses despite notices being put up by the council itself prohibiting horses from using the path, If the path were to be used as a bridleway our family would certainly be discouraged from using it especially when walking dogs, we certainly would not want to come across a large horse or group of horses and riders in this situation especially on the narrow parts of the path.

We would wish to stress we have no objection to horses and riders per se being very much part of the local rural environment. We do not consider however that the potential dangers to all users if the path is allowed to be used by riders and horses that this is a suitable path by its very nature to be used as a bridle path.

If the proposal were to be passed by the Council our family would not feel at all comfortable using the path in future if only to avoid any potential conflict and the risk implications of encountering horses and riders on the narrow and blind parts of the path. On the grounds of safety alone and its added unsuitability in terms of ground conditions the proposal should be rejected by the Council in the interests of walkers, joggers horses , riders and visitors to the area.

As joint owner of the land which the above footpath cross's I wish to object to the proposal that it should be designated as a bridleway.

The footpath has always been used by local people as a short cut to get to the local school and church from Moss Lane Wrightington to Mossy Lea Road for many many years. The footpath is extremely narrow in places with a number of blind turns it also gets very wet in winter. I consider it would be a danger to walkers using the path if they were confronted by horses and riders especially in groups and if they were walking dogs in particular on the narrow parts of the path. Such encounters would be a recipe for potential conflict and danger to all parties.

Horses would also cause the path to become even more muddy and dangerous underfoot in the winter months.

This path has always only been used by walkers it is only in recent years this appears to have become a problem, I am aware of people objecting to the Council of its use by riders and horses and the problems it causes, the council has erected signs in the past informing horse users it is not a bridle path.

While I have no objection to horses and riders using the appropriate paths and bridle ways in the area, in fact it is part of rural life I do not consider this particular path by reasons of its narrow nature ,blind corners and condition in winter in places it is suitable as a bridleway to the detriment of walkers and local people. The point at which it joins Moss lane by its nature would also be a danger to traffic and horses and riders.

I consider therefore the application should be rejected by the Council on the grounds I have outlined as not suitable for a bridleway.
