

# St. William's Catholic Primary School Determined Admissions Policy September 2026 to August 2027



St William's is a Catholic Primary School provided by the Diocese of Lancaster and is maintained by the Lancashire Local Authority as a voluntary aided primary school. The admissions process is part of the Local Authority Co-ordinated Admissions Scheme.

BEBCMAT is the admissions authority and is responsible for taking decisions on applicants for admission.

The Governors of St William's Catholic School welcome applications from Catholic and non-Catholic parents who would like their children educated within the aims and ethos of St William's Catholic School.

St William's is a Catholic Primary School in which the Catholic faith and the teachings of the Catholic Church are essential aspects of school life and influence the school curriculum.

We ask all parents applying for a place here to respect this ethos and its importance to the school community. This does not affect the right of parents who are not of the faith of this school to apply for and be considered for a place here.

BEBCMAT is responsible for admissions within the requirements of the law. In doing so, the Trust has regard for:

- The advice of the Diocesan Trustees on the nature and purpose of Catholic schools;
- The Trust's responsibility towards the school and the Catholic Community it serves;
- The Catholic character of the school and its Mission Statement.

The Governing Body Admissions Committee is comprised of the following governors: Mrs Heather Hogarth (Head), Mrs. Clements (Chair of Governors), Mr. G Power (Vice Chair of Governors) and Mrs. Winstanley (Parent Governor).

It is the duty of the Trust to comply with class size limits at Key Stage One. This means that the school cannot operate classes in Key Stage One of more than 30 children. No more than 30 children will be admitted to any one reception or infant class.

For September 2025, the Admission Number for St William's Catholic Primary school was 12. A Total of:

- 9 Applications were received by the closing date.
- O Applicants were admitted under criterion 1 of the 2024 policy
- O Applicants were admitted under criterion 2
- O Applicants were admitted under criterion 3
- 3 Applicant was admitted under criterion 4, 5, 6
- O Applicant was admitted under criterion 7
- 6 Applicants were admitted under criterion 8

The Governing Body has set the planned admissions number for September 2026 at 12.

# **Arrangements for admission in September 2026**

- 1. Applications for a place at the school should be made on the Local Authority Common Application Form or online and returned to the Local Authority no later than 15<sup>th</sup> January 2026
- 2. Parents must complete the Common Application Form available from the Local Authority. Parents who wish their application school to be considered against the priority faith criteria should also complete the school's Supplementary Information Form. This information may result in your application for a place in this school being considered against lower priority criteria, as the Governing Body will have no information upon which to assess the application on the basis of the applicant's baptism.

The Supplementary Information Form should be returned to the school by <u>15<sup>th</sup> January</u> 2026.

- 3. Each Catholic applicant will be required to produce a baptismal certificate or other evidence of baptism.
- 4. The Admissions Committee of the Governing Body will consider all applications at the same time after the closing date.
- 5. Parents or guardians will be informed of the outcome of their application in writing by the Local Authority on **16**<sup>th</sup> **April 2026**.
- 6. As required by law, all children with a Statement of Special Educational Needs naming the school will be admitted before the application of the oversubscription criteria.

#### **Oversubscription Criteria**

The Governors will admit up to 12 children in September 2026. If the number of applications for admission exceeds the places available, children will be admitted subject to the following criteria and will be used to form a priority order.

- Baptised Catholic Looked after children or a child who was previously looked after, but immediately after being looked after became subject to an adoption, child arrangement order, or special guardianship order or those children who appear to the school to have been in state care outside of England and ceased to be in state care as a result of being adopted.
- 2. Baptised Catholic children who live in the parishes of St William's and St Bernard's with a sibling in the school at the time of the expected admission.
- 3. Other Baptised Catholic children who live in the parish of St William's and St Bernard's.
- 4. Other Baptised Catho<mark>lic children with a sibling in the school</mark> at the time of expected admission.
- 5. Other Baptised Catholic children.
- 6. Other children who were previously looked after, but immediately after being looked after became subject to an adoption, child arrangement order, or special guardianship order or those children who appear to the school to have been in state care outside of England and ceased to be in state care as a result of being adopted.
- 7. Other children with a sibling in school at the time of expected admission.
- 8. Other children.

In the event of oversubscription in any of the above criteria, places will be allocated according to the following tie breaker criterion:

#### **Lancashire Schools:**

Applicants living nearest to the school. The distance measure is a straight line (radial) measure from the centre of the building of the applicant's home address to the centre of the school building. Distances are measured using the *Councils' Geographical Information System*. If the Governing Body is unable to distinguish between applicants in any of the oversubscription criteria using this distance tie breaker (e.g. applicants in the same block of flats) places will be offered via a random draw.

#### **EXPLANATORY NOTES**

#### **Baptised Catholic**

Please note this is not a change in our admission policy, it is a definition for the purpose of clarification. For admission to this Catholic school a Baptised Catholic is

- One who has been baptised into full Communion with the Roman Catholic Church by the Rites of Baptism of one of the various ritual Churches in communion with the See of Rome (Proof of Baptism with a copy of a Baptismal Certificate or details of the date and place of Baptism will OR may be required)
- A child baptised in another Christian Faith who has been received into full Communion with the Roman Catholic faith (Proof of Baptism and reception from the Register of Receptions or Baptismal Register will OR may be required.)
- A child who, with his or her family, is enrolled in a recognized course of preparation leading to Catholic Baptism (Proof of enrolment with details of the place and date of enrolment from the appropriate parish records will OR may be required.)
- One who is a member of the Eastern Christian Churches and the Orthodox Churches.
   (Proof of Baptism with a copy of a Baptismal Certificate, details of the date and place of Baptism or certificate of reception will OR may be required.)

## Children in public care

This means a child who is looked after by a Local Authority in accordance with section 22 of the Children Act 1989. This is a child in public care that is in the care of a Local Authority or provided with accommodation by that Authority.

#### **Siblings**

Sibling refers to full brothers and sisters, half brothers or sisters, adopted brothers or sisters, or the child of the parent/carer's partner where the child for whom the place is sought is living in the same family unit at the same address as that sibling. Stepchildren or foster children who live at the same address are also classed as siblings

# **Address of Pupil**

The address used on the school's admission form must be the correct one at the date of application. If the address changes subsequently, the parents should notify the school. In some cases, for example, where shared parental living arrangements are in place, a child's address may be difficult to determine. In these circumstances, the address used for child benefit purposes, i.e., the address of the parent claiming the child benefit will be used. If you are moving house and applying for the school and it is not oversubscribed, using your new address may not be a problem. In the event of oversubscription, it may be possible to

consider your application on the basis of an address you are intending to move to. You must be resident at a specific address and not just have a stated intention to move to an area. You must provide evidence that you have exchanged contracts on a house or have an offer of a tenancy on a property in which you intend to live and which will be your home when your child would start school. This evidence must be submitted as soon as possible and no later than the deadline of <u>15<sup>th</sup> January 2026</u>. Further evidence, e.g. utility bills, may also need to be submitted *immediately*.

## Multiple Births including Twins/Triplets etc.

Where there are twins wanting admission and there is only a single place left within the admission number, then the Governing Body will exercise as much flexibility as possible within the requirements of infant class sizes. If places for both of the twins, or all triplets, etc cannot be offered, the family will be advised accordingly. This may also apply to siblings who are in the same year group. If only a single place can be offered then the Governing Body, as Admission Authority, will use a random draw system to decide which pupil receives an offer.

#### **Late Applications**

Applications received after the closing date <u>15<sup>th</sup> January 2026</u> will be treated as late applications. Only in special circumstances, and where appropriate evidence is provided, will applications received after the closing date (but offers of places have been made) be considered alongside those received on time.

# **Waiting list**

A waiting list for children who have not been offered a place will be kept and will be ranked according to the *admissions/oversubscription* criteria. Parents/Guardians are invited to contact the school if they wish to be informed of their child's position on the waiting list. The waiting list will be closed at the end of the autumn term.

# **Fraudulent Applications**

Where the Governing Body discovers that a child has been awarded a place as a result of an intentionally misleading application from a parent, for example, where a false address has been provided, the Governing Body is required to withdraw the offer of a place. The application will then be considered afresh and a right of appeal offered if a place is refused.

# **Appeal Arrangements**

If an application for admission has been turned down by the Governing Body, parents can appeal to an Independent Appeals Panel. This appeal should be sent in writing to the Clerk of the Governors at the school within 14 days of Notification of Refusal. The date of Notification will be considered to be 2 working days after posting by first class of the refusal to offer a place. The

parents must give their reasons for appealing in writing. The decision of the appeal panel is binding on the parents and on the Governing Body.

#### In Year Admissions

In-year admission is the process of applying for a school place during the school year. Any applications for the intake made after the start of the autumn term will be treated as an in-year application.

The in-year admission process is managed by the school. Parents are required to complete the in-year application form, which is available from the school website.

Where a place cannot be secured, parents will be offered a legal right of appeal to an independent appeal panel.

Lancashire County Council administers the appeals process on behalf of the school. Parents can complete the school's appeal form on Lancashire County Council's website.

#### **Deferred Entry**

This allows Parents to request that the date their child, if below compulsory school age, is admitted to school is deferred to later in the school year or until the term when they reach compulsory school age.

#### **Part Time Provision**

The decision with regard to the allocation of a morning or afternoon place is delegated to the Headteacher

All parents requesting a place, either because they are new to Lancashire or because they are wishing to transfer schools within Lancashire during the school year will be required to complete the relevant Local Authority Application Form available at <a href="www.lancashire.gov.uk/schools">www.lancashire.gov.uk/schools</a> - school admissions

Parents who wish their application to this Catholic school to be considered against the priority faith criteria should also complete the school's Supplementary Information Form and return it directly to the school. If the school is oversubscribed with mid-year applications at the time of requested admission, failure to complete the Supplementary Information Form may result in your application for a place in this school being considered against lower priority criteria.

The admission of all students to Lancashire schools will be co-ordinated by the Lancashire Local Authority, in line with recent changes in legislation.
