### **ROAD TRAFFIC REGULATION ACT 1984**

# LANCASHIRE COUNTY COUNCIL (GREAT ECCLESTON AREA, GREAT ECCLESTON (VARIOUS ROADS), WYRE BOROUGH) (REVOCATION, 20MPH, 30MPH AND 40MPH SPEED LIMIT) ORDER 2013

The County Council of Lancashire, in exercise of its powers under Sections 82 (2), 83 (2) and 84 (1)(a) and (2) and Part IV of Schedule 9 of the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

#### 1. Revocations

"The Lancashire County Council (St Mary's Road Area Zone, Great Eccleston, Wyre Borough) (20mph Speed Limit) Order 2004", is hereby revoked in full.

"The Lancashire County Council (B5293 and Various Roads, Great Eccleston, Wyre Borough) (30mph Speed Limit) Order 1994", is hereby revoked in full.

"The Lancashire County Council (Copp Lane, Great Eccleston and Elswick, Wyre Borough) (40mph Speed Limit) Order 1995", is hereby revoked in full.

## 2. 20mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on any of the roads or lengths of road set out in the Schedule to this Order, located within the Great Eccleston Area, Wyre Borough.

## 3. Restricted Road (30mph Speed Limit will apply)

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour along the following lengths of road which shall become restricted Roads (as defined in section 82 of the Road Traffic Regulation Act 1984):

**Copp Lane** from a point 27 metres west from the centre line of its junction with Chesham Lodge for a distance of 305 metres in a westerly direction;

Hall Lane from a point 108 metres south from the centre line of its junction with Barrows Lane for a distance of 438 metres in a south easterly direction;

## 4. 40mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on Copp Lane from a point 227 metres north from the centre line of its junction with Beech Road to a point 305 metres west from the centre line of its junction with Chesham Lodge.

## 5. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.

#### 6. Commencement of Order

This Order may be cited as the "Lancashire County Council (Great Eccleston Area, Great Eccleston (Various Roads), Wyre Borough) (Revocation, 20mph and 30mph Speed Limit) Order 2013" and shall come into force on the 18<sup>th</sup> day of March 2013.
