

NOTICE OF PROPOSAL
HIGHWAYS ACT 1980
LANCASHIRE COUNTY COUNCIL
(COTTON TREE LANE, COLNE, PENDLE BOROUGH) (SPEED HUMPS)

NOTICE IS HEREBY GIVEN that in accordance with Section 90A of the **Highways Act 1980**, Lancashire County Council propose to introduce road humps in the following locations:

- 1) Cotton Tree Lane, Colne, from a point 36.9 metres north west of its junction with the centreline of Boulview Terrace for a distance of 3 metres in a north westerly direction;
- 2) Cotton Tree Lane, Colne, from a point 31.5 metres south east of its junction with the centreline of Boulview Terrace for a distance of 3 metres in a south easterly direction;
- 3) Cotton Tree Lane, Colne, from a point 221.8 metres north west of its junction with the centreline of Lambeth Street for a distance of 3 metres in a north westerly direction;
- 4) Cotton Tree Lane, Colne, from a point 150.7 metres north west of its junction with the centreline of Lambeth Street for a distance of 3 metres in a north westerly direction;
- 5) Cotton Tree Lane, Colne, from a point 78.7 metres west of its junction with the centreline of Lambeth Street for a distance of 3 metres in a westerly direction;
- 6) Cotton Tree Lane, Colne, from a point 7.2 metres west of its junction with the centreline of Lambeth Street for a distance of 3 metres in a westerly direction;
- 7) Cotton Tree Lane, Colne, from a point 61.3 metres east of its junction with the centreline of Lambeth Street for a distance of 3 metres in an easterly direction;
- 8) Cotton Tree Lane, Colne, from a point 132.4 metres east of its junction with the centreline of Lambeth Street for a distance of 3 metres in an easterly direction.

The speed humps will have a maximum height not exceeding 75mm.
