
Did you know that between 5 and 8 percent of children in the UK have a food allergy?

You must tell parents if any food you provide (either 'homemade' or purchased) contains any of the 14 major allergens. The 14 allergens are: **celery**, **cereals containing gluten** (such as barley and oats), **crustaceans** (such as prawns, crabs and

lobsters), eggs, fish, lupin, milk, molluscs (such as mussels and oysters), mustard, peanuts, sesame, soybeans, sulphur dioxide and sulphites (at a concentration of more than ten parts per million) and tree nuts (such as almonds, hazelnuts, walnuts, brazil nuts, cashews, pecans, pistachios and macadamia nuts).

The Food Standards Agency website has all the information that you need to help you, including free training and templates

You will need to ensure that this information is easily accessible so that all adults are fully aware of the child's allergy when preparing or serving food.

Those preparing or serving food will need to be vigilant to ensure there is no cross contamination including when cleaning food preparation areas and when storing food. The check list on the website is very useful to help you consider if you have the appropriate systems in place.

The Food Allergy Awareness Training for Childcare Practitioners is online recorded training (4.5hours) and can be purchased for £17. It is ideal for all childcare practitioners, including childminders. The training includes:

- Latest allergic Ingredient law and updates and EYFS context.
- Common mistakes when working with allergenic ingredients.
- Defining food allergies, food intolerances, and Coeliac Disease.
- 14 food allergies named in legislation and the dangers of hidden ingredients.
- How to design allergy-aware recipes and ingredient factsheets for staff and parents.
- How to make your premises allergy ready incl. suppliers, delivery and cooking.
- Identifying allergenic attacks and emergency First Aid and EpiPen use on young children.

Adults must also be aware of what might happen if a child has an allergic rection and the action they must take. Paediatric First Aid Training contains training on how to help a child suffering from anaphylactic shock or other allergic reaction. If you have a child attending who has been prescribed an adrenaline auto injector pen (e.g. epi pen) then staff should undertake specialist training for this individual child.

Let's Celebrate!



This week we are shouting a wonderful Wednesday Well Done to three settings in Lancashire who have recently has their Ofsted inspection reports published

- Leanne Baker a childminder in Leyland has shared her positive inspection experience with us. Leanne explained how right from her notification call she was put at ease. The inspector spent a of her time observing Leanne with the children and taking notes and only really questioned Leanne when it came to discussing safeguarding. Leanne led her own inspection, and also did a tour of her setting with the children for the inspector at the start. Leanne's top tip would be to have out what paperwork you would like the inspector to see, have it out ready. For example, Leanne had her parent comments out ready to show. The inspector wanted to see the paperwork related to children with disabilities and health care needs. The inspection report details how- 'The childminder has a very caring and nurturing nature that instantly provides children with comfort and support when needed. They receive lots of cuddles and words of reassurance. This helps children to feel secure and boosts their emotional well-being.'
- Jenna Riding a childminder in Rossendale has had her inspection report published, with her inspector noting ' The childminder is very committed to her role. She provides an exciting and interesting environment and activities for children to explore and learn from. This provides children with space to develop and grow in their own individual ways.' Jenna shared that the inspector called her several days before arriving for the inspection which helped to settle her nerves having spoken to her beforehand. The inspection took around 3 ½ hours and it was quite intense with the questioning, but Jenna tried to remain calm and answer all the questions. Her top tip is to stay calm despite any nerves and get into the flow of the day to showcase yourself.
- Little Stars at the Oaks in Accrington are our third setting this week who are celebrating their positive inspection report. Manager Pat Boydell said that she has recently had Jill Anderton and Michelle Jones from the team, visit her setting, which really helped prepare for the inspection. She said it was not as stressful as she anticipated and the inspector was great. Her learning walk went really well. The inspector made reference to how 'Children enjoy their day in this vibrant and exciting nursery environment. Staff create a well-organised and welcoming space for children to explore, learn and develop. Children are kind, caring and motivated learners.' Pat's top tip would be to keep calm and keep doing what you would usually do daily.

Group consultations will last two hours and will provide an opportunity for anonymous case discussion using a process facilitated by the EP. It will offer a collaborative space for EY SENCos to learn from each other and share good practice whilst supporting SENCos to leave with a range of supportive suggestions.

Early Years Expansion - Capital Funding Phase Two A reminder for settings as the deadline approaches

To support the expansion of the early year entitlements £2,015,836 of capital funding has been made available to increase the numbers of places available for 2 year olds and under 2's. We completed phase one which supported the first stage of the expansion, where we have created nearly 300 new places. From September 2025 eligible 2 year olds and under 2's will be able to access up to 30 hours of early education funding. We have reassessed the childcare market and have identified the areas where we may have a gap in places for 2 year olds and under 2's, where we have a gap in places these will be our priority areas for phase two.

We have a small amount of capital funding remaining to support the roll out of phase two. Please find attached details of our priority areas and information regarding the capital funding available, how to find out if you are in a priority area and an overview of the application process.

Experts and Mentors Programme Evaluation Report

The DfE is pleased to announce the publication of the EYTDA Provider Guidance, developed with a sector-led implementation group to support training providers in delivering high-quality apprenticeship programmes for early years professionals.

Recommended for HEIs, training providers and sector stakeholders, the EYTDA Provider Guidance details key requirements for apprenticeship delivery, covering:

- · Eligibility
- · Programme structure
- · Mentoring
- Assessments

- · Quality assurance
- · Compliance
- · Roles of providers and employers

Training providers are expected to be ready to offer EYTDA apprenticeships from September 2026, although some may be ready earlier.

Early Years Foundation Stage (EYFS) nutrition guidance changes from September 2025



From September 2025, it is intended that the safeguarding and welfare requirements of the EYFS will ask that providers '**should**' have regard to this nutrition guidance. This means providers must take this guidance into account and should follow it unless there is good reason not to. This guidance will support providers to understand how to implement the existing EYFS requirement that states: 'Where children are provided with meals, snacks and drinks, these must be healthy, balanced and nutritious'

Your input is invaluable to us – Help us to tailor support for children moving on to school

We are looking into ways in which we can particularly support some of our children that we know might struggle when they move to school in September. This is so that we can try and support those children to have a successful transition to their new reception class.

We understand how important it is for preschool children from your setting to have a smooth and successful start in their new reception class this September. Providing extra support for those children who might face challenges during this big transition is an area that is of high focus you and for Lancashire too. You know that starting Reception class is a major milestone, and we know it can be a bit overwhelming for some children. Here are a few reasons why they might find it difficult to settle in:

- 1. **Separation Anxiety**: It's natural for children to feel anxious when they are separated from their parents or caregivers for the first time, but some could find this overwhelming.
- 2. **New Environment**: The school setting can be quite different from what they're accustomed to in your setting. For children who are sensitive to change, this new environment can be particularly challenging.
- 3. **Social Adjustments**: Meeting new friends and forming connections can be daunting and a barrier for some that are well below their expected levels with social development.
- 4. **Different Routines**: The structure of a school day is often more rigid than what they're accustomed to in your nursery or home setting.
- 5. **Developmental Differences**: Every child develops at their own pace, and some might not be as ready for the academic and social demands of school as others.
- 6. **Communication Skills**: Limited language skills can make it hard for children to express their needs and feelings, leading to frustration and anxiety (You may be providing interventional support, for instance, through Wellcomm, for these children).
