## What will the LSIP contain?

We can offer you an LSIP to contain (data from 2024/25):

- School and Pupil Characteristics
- **NEW** District Summary Page
- EYFS ELG judgements
- Year 1 Phonics Screening Results with additional charts/graphs (Disadvantaged, Non-Disadvantaged)
- Year 2 Phonics Results of re-checks
- <u>Optional</u> Year 2 Teacher Assessment Using the KS1 Teacher Assessment Framework and associated language (Please note, this section will only be included if your school <u>choose</u> to submit KS1 Data in July, more information on how to do this will be provided in due course)
- Multiplication Tables Check (MTC) Section
- Year 6 All KS2 Test Results and Writing and Science Teacher Assessment Using the KS2 Teacher Assessment Framework and associated language
- A version 2 of the LSIP to be released in the Spring Term, containing any data changes

The document will offer you:

- Breakdown of results for all children, including the percentage achieving each judgement
- Comparative data to the average of all Lancashire Primary schools

- Graphical representation of results in the style of the LSIP
- NEW Disadvantaged/Non-Disadvantaged absence data
- **NEW** Three-year average School Level (EYFS, Year 1 Phonics, KS2)

In addition to the above, we are delighted to announce that at the time of release of the main LSIP, we will be able to release the Closing the Gap Reports and the Governor LSIP. Both releases will be considerably earlier, as was the case last year.

You will not need to do anything beyond your usual submission of data to receive your LSIP. The exception to this will relate to the <u>optional</u> submission of KS1 and MTC Data. As mentioned above, further information on how to do this will be provided in due course.
