The inspector asked lots of questions on the initial phone call and put Janet at ease. The inspector was mindful of how staff were feeling on the day and offered breaks if needed. Janet said she managed to pass on all she wanted at the learning walk. The inspector noted- 'Partnerships with parents are of an exceptionally high standard. Parents are encouraged to play an active role in children's learning. Parents comment on the all-round support they receive from the nursery. For example, parent workshops are offered, where they can attend and learn information to support them.'

They have since celebrated their continued 'outstanding' grade with a big party. Janet's top tip is to embrace the inspection by celebrating what you do daily and ensure that you capture the best of yourselves during the learning walk.

Blue Bear Preschool and Nursery in Freckleton are also celebrating their 'outstanding grade'. Their reports captures how well -'Leaders and staff plan and implement an inspirational curriculum with children at the very heart. Their precise knowledge of children's abilities enables them to adapt their strong teaching to meet children's targeted needs. 'Manager Anne Chauhan said that the inspector was lovely, she asked about anxious staff and made them feel at ease. The positive attitude of the inspector made it easier to showcase what the setting does best and what it is like to be a child at the setting. Anne also shared that her learning walk went really well.

## DfE announces fully funded Early Years SENCO training for 2025/26

As part of the government's plan to break down barriers to opportunity, improving outcomes for children in early years education, the Department for Education is very pleased to announce that Best Practice Network (BPN) has been selected as our delivery partner to provide 1000 SENCO training places in financial year 2025-26.



The key aim of the programme is to increase the number of qualified SENCOs available to children in group-based settings and

childminder settings, who have the knowledge and skills to properly fulfil the role of a SENCO described in the code of practice and in the role description.

Training is available across England and is open to Early Years educators currently working as, or due to start working as, a Special Educational Needs Coordinator in their setting.

Applicants from group-based private, voluntary or independent (PVI) settings must hold a full and relevant level 3 Early Years qualification. Childminder applicants must hold either a full and relevant Early Years level 3 qualification or have a level 2 Early Years qualification but have fully completed at least one level 3 Early Years training module and have significant experience of working in Early Years.
