This guidance is to be used if you wish to apply for UPE and you meet one of the below criteria

- You **have your BRP** that has expired **less than 18 months ago** and you **have** provided your fingerprints before
- You **have your BRP** that has expired **less than 18 months ago**, but you **have NOT** provided your fingerprints before, but you **have a current valid passport**
- You **do not have a BRP** (e.g. you lost it), but you **have a current valid passport**



If any other cases, please refer to the guidance on how you apply for UPE using a different route (UPE application from) [here](#).

Do not use a different route (a form) if you have either

- a valid passport
- a biometric residence permit (BRP) and you have previously given us your fingerprints

1. To start your application, please follow the link <https://www.gov.uk/guidance/applying-to-the-ukraine-permission-extension-scheme> and click "Start now"

Apply

You should only make an application to the Ukraine Permission Extension scheme when your current permission has 28 days or less remaining until it expires

Before you apply, you should:

- check when your current permission expires by signing into your UKVI account and plan for when it is the right time to make an application
- ensure you are inside when you apply
- not travel outside the UK while your application is being considered
- ensure that you have
 - your passport
 - your expired BRP (if you have one)
 - documents you will need if [applying for a child under the age of 18](#)

Create a UK Visas and Immigration account

To use this service, you need to create an account.

Once you have an account, you can use it to confirm your identity, apply and use other Home Office services.

- passport
- email address
- phone number

If you need to give someone application access so they can apply for you, you also need their email address and phone number.

Who can create an account

You can create an account for yourself or someone else in some cases - for example, your young child.

Using the app

The quickest way to confirm your identity is on the 'UK Immigration: ID check' app.

To use the app, you will need:

- your identity document
- an iPhone 7 or newer, or an Android phone that can make contactless payments

You can use someone else's phone if you need to. The app can be deleted once your identity has been confirmed.

Going to a visa centre

If you cannot use the app, you may need to have your fingerprints and photo taken at a visa centre.

If you need to do this, you will be able to book your appointment later.

If you select **"No"**, you will see the next information **"You may not be eligible for the Ukraine Permission Extension Scheme. As you have never had permission to be in the UK, you may not be eligible for this scheme. You can continue with this application but it may not be successful."**
