(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

**NOTICE IS HEREBY GIVEN** that Lancashire County Council intends to make an Order under **Section 14(1)** (a) of the Road Traffic Regulation Act 1984, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this Order.

- 1. No person shall cause any motor vehicle to proceed over the following lengths of highway in the Borough of West Lancs.
  - i. Tonine Road, Up Holand, Slelmersdale from its junction from to its junction with Higher Lane to its junction with Sandbrook Road.
  - ii. Cinnamon Brow, Up Holand, Slelmersdale from its junction to its junction with Higher Lane to outside number 2a Cinnamon Brow.
  - iii. Higher Lane, Up Holand, Slelmersdale from its junction with Church Street to its junction with Alma Hill.
  - iv. Alma Hill, Up Holand, Slelmersdale from its junction with to its junction with Alma Road to the side of 107a Alma Hill.
- 2. Nothing in this Order shall apply to persons engaged in the carrying out of the works.
- 3. The probations will be operative on the following time and dates provided;
  - i.Tontine Road, Up Holland from 0800 hours on Monday 30<sup>th</sup> June 2025 until 1600 hours on Friday 19<sup>th</sup> September 2025.
  - ii. Cinnamon Brow, Up Holland from 0800 hours on Monday 30<sup>th</sup> June 2025 until 1600 hours on Friday 19<sup>th</sup> September 2025
  - iii. Higher Lane, Up Holland from 0800 hours on Monday 30<sup>th</sup> June 2025 until 1600 hours on Friday 19<sup>th</sup> September 2025.

Access for emergency services will be maintained whenever and Wherever possible. The prohibitions will only be operative when indicated on site by the presence of the appropriate traffic signs in accordance with. The Traffic Signs Regulations and General Directions 2016.

4. Vehicular access for residents will be maintained whenever and wherever possible. Pedestrian access to properties will always be maintained.

5. An alternative route for vehicular traffic affected by the closures will be Sefton View - Moor Road - Orrell Road - School Lane - Parliament Street - Grove Road - Dingle Road.

The temporary prohibition is necessary to allow gas mains diversion works to be carried out by Cadent Gas.
