(LANCASTER CITY CENTRE)
(ANTI-TERRORISM PROHIBITION OF TRAFFIC)
NOTICE 2025**

NOTICE IS HEREBY GIVEN that Lancashire County Council consider it necessary because of the likelihood of danger to the public or for the purpose of preventing or reducing damage connected with terrorism to prohibit use by vehicular or pedestrian traffic and prohibit waiting and loading and unloading when instructed as set out below in relation to the lengths of road on the plan in Schedule 1.

This Notice is made under **Sections 14(2)(b), 14(4)(a), 22C(5) and 22D** of the **Road Traffic Regulation Act 1984** as amended ("**the Act**"). This Notice provides that:

1. This Notice shall come into force at 2100 hours on Sunday 8th June 2025 and be operative until 2100 hours on Monday 9th June 2025.
2. If instructed by the Gold Commander, or a person authorised or required to act on the Gold Commander's behalf of at least the rank of Inspector the use of all or any of the highways (or parts thereof) situated within the land edged green as shown on the plan in Schedule 1 by vehicular and/or pedestrian traffic is prohibited or restricted.
3. If instructed by the Gold Commander, or a person authorised or required to act on the Gold Commander's behalf of at least the rank of Inspector, where the use of any of the highways (or parts thereof) is prohibited or restricted under Article 2 hereof and the prohibition or restriction is no longer necessary under S14(2) of the Act because the likelihood of danger to the public, or of serious damage to the road(s) connected with terrorism has sufficiently diminished as communicated to the traffic authority by the Gold Commander the said prohibition and restriction on use shall cease.
4. Within the land edged green as shown on the plan in Schedule 1 waiting, loading or unloading is prohibited if instructed by the Gold Commander, or a person authorised or required to act on the Gold Commander's behalf.
5. If instructed by the Gold Commander, or a person authorised or required to act on the Gold Commander's behalf, where waiting, loading or unloading is prohibited under Article 4 hereof and the prohibition is no longer necessary under S14(2) of the Act because the likelihood of danger to the public, or of serious damage to the road(s) connected with terrorism has sufficiently diminished as communicated to the traffic authority by the Gold Commander the said prohibition shall cease.
6. The prohibition in Article 2 shall not apply to any police, fire brigade or ambulance vehicle being used in the case of an emergency.

7. This Notice may prevent at any time access for pedestrians to any premises situated on or adjacent to the highway, or to any other premises accessible for pedestrians from, and only from, the highway.
