Ordnance Road and Buckshaw Station Approach, Chorley

The local County Councillor raised concerns regarding parked vehicles along Ordnance Road and Buckshaw Station Approach causing issues for drivers by obstructing the free flow of vehicular traffic.

Visits were undertaken by officers on different days and at different times of the day and confirmed that there were parking issues in this location, which is causing serious problems.

To address the issue, officers propose to introduce No Waiting at Any Time restrictions to remove instances of obstructive parking along the roads to ensure forward visibility and avoid vehicle conflicts.

The purpose of this proposal is to facilitate the passage of vehicles along Ordnance Road and Buckshaw Parkway maintaining free movement along the road and improving overall road safety for all road users.

The purpose of this proposal is to remove the potential for vehicles to park in an obstructive manner near to this junction. This will improve access, sightlines and help to maintain the flow of traffic thereby increasing safety for highway users.
